# Joint President and **Executive Officer** Report

We are pleased to report a successful 2024/2025 Annual Report. BIAT left 2024 and entered 2025 with momentum, confidence and a strong vision for what comes next. Over the past year, we have built on solid foundations, delivered high-value programs, forged new partnerships, and continued to amplify the voices of people with brain injury. These achievements are not an endpoint but a launchpad, giving us the platform to take bold steps into the future.

This has been a year of exceptional achievements, with the National Assistance Card growing in reach and recognition, and expanding to autistic people nationally, marking a milestone moment. The JustACE Program continues to demonstrate its value, providing vital support for Tasmanians navigating the justice system as defendants/offenders. What began as an ambitious pilot project is now demonstrating how sustained investment can transform lives.

The About Me and Employ Me Projects are innovating how people living with brain injury and other disabilities share information about themselves to the community, empowering individual strengths-based disclosure with pride and dignity. At the same time, BIAT's general awareness work has continued to grow, ensuring that the experiences of people with brain injury are heard and helping to foster community understanding. Through campaigns, resources and events, and with the help of our partners and lived experience leaders, we have shifted community understanding.

Innovation remains at the heart of our work. Co-designing resources with people with lived experience, leveraging technology and accessible design, and keeping our focus on inclusion ensures that our services continue to make a real impact. The work ahead is about turning pilots into permanent solutions, recognition into everyday practice, and stories into lasting reform.

We know that we couldn't do this important work without the support of our partners and funding bodies. We are grateful to the Association for Children with Disability for their work delivering the Empower Me Project and Amaze for their work supporting the rollout of the National Assistance Card to the autistic community nationally.

We thank the Commonwealth Government Department of Social Services for funding our Information Linkages and Capacity Building (ILC) activities (the National Assistance Card and the Employ Me Project); the Tasmanian Government Department of Justice for funding the JustACE Program; and the Motor Accident Insurance Board, for funding the About Me Project, and BIAT's community awareness and engagement activities.

We also acknowledge and thank our volunteers and people with lived experience who are at the heart of what we do. They are with us every step of the way, whether it's working with our project teams to co-design and test resources, speaking and sharing their lived experience, or as Committee of Management members who ensure the effective running of the Association.

Finally, we thank BIAT's hard-working employees, who have persevered through another year of funding uncertainty to achieve exceptional outcomes. The team has gracefully weathered this unpredictability, along with significant changes, such as the team growing in size from eleven to nineteen, and moving into front-line service provision with the JustACE Program being delivered onsite. Despite the challenges, the team's values, passion, dedication and professionalism are what drive the organisation and the success of all our endeavours. We acknowledge and thank staff who have left BIAT during this period. In particular, we recognise Deborah Byrne, who served as Executive Officer for 22 years and retired in August 2024. She was awarded Life Membership at the 2024 Annual General Meeting in appreciation of her dedication and commitment. We also acknowledge Sienna Tilley, who contributed to the development and delivery of several of BIAT's core projects during her five years with us. We wish them all the best in their new endeavours.

As we enter a new financial year, we have the happy news that our ILC-funded projects (the National Assistance Card and Employ Me) have been transitioned to the new Commonwealth Department of Health, Disability and Ageing, coming under the Foundational Supports program schedule. Additionally, MAIB has funded BIAT's Information and Awareness Project for three (3) years. This gives the Association more stability and hope than it has had in recent years.

The future is bright because we have the right foundations, the right partners and the right vision. We look forward with optimism, energy and determination to continuing our work as the voice of brain injury in Tasmania.

BIAT is committed to raising awareness of brain injury and educating the broader community about its impacts and preventative measures. Throughout the reporting period, we engaged with a wide range of communities through several key programs and initiatives:

#### **Custody for Life Program**

The Custody for Life program operates in partnership with Tasmania Police and Community Youth Justice. The program targets young people referred to sessions following cautions for offenses that pose a high risk of brain injury, such as common assault or traffic violations.

#### **Program Improvements**

To improve attendance, we implemented a proactive follow-up process that includes phone calls, emails, and mailed letters to confirm participation. As a result, attendance has increased significantly from an average of 60% to nearly 100%.

#### **Rotary Youth Driver Awareness Program**

As part of the Rotary Youth Driver Awareness (RYDA) program, BIAT facilitated the delivery of Crash Investigator sessions in the southern and northern regions of the state. The Crash Investigator segment remains the most popular element of the RYDA program, largely due to the involvement of Nicho Baily, who copresents each session. Nicho shares his personal experience of living with a brain injury sustained in a motor vehicle crash, providing a deeply impactful, real-life scenario for students to reflect on.

### **Brain Injury Peer Support Group Update**

In 2025, the Brain Injury Association of Tasmania made significant changes to the delivery of our Peer Support Program to improve engagement, accessibility, and sustainability. Following a comprehensive review in late 2024, we transitioned away from face-to-face, staff-facilitated Peer Support Group meetings and instead focused on peer-led coffee catch-ups and bi-monthly Information and Education Sessions.

The peer-led coffee catch-ups in Hobart and Ulverstone/Burnie have demonstrated strong and consistent engagement, with positive feedback from participants. Unfortunately, due to ongoing low or no attendance, the Launceston coffee catch-ups have been placed on hold.

Our new structure allows for a more sustainable program, driven by people with lived experience.

#### **Coffee Catch-Ups**

In 2025, we focused our Peer Support Program on peer-led Coffee Catch-Ups in Hobart and Ulverstone/Burnie, providing informal support and connection for people with brain injury. Our dedicated volunteers, Claire and Bianca, bring their lived experience and commitment, central to the success of these gatherings.

Healing in community is the most powerful kind of healing.

But meeting others with a TBI/ABI, hearing how they have reshaped their lives and reinvented themselves—despite immense obstacles—has been nothing short of brilliant.

I've met so many truly amazing people. I'm deeply grateful for the social connection, shared stories, and the reminder that we are not broken—we are evolving.

#### **Newsletters**

Throughout the reporting period, BIAT produced five newsletters, which were distributed to our mailing list and newsletter subscribers. These newsletters provided updates on the organisation's activities, shared valuable information on brain injury, and highlighted local events and opportunities relevant to our audience. Each issue was crafted to keep our subscribers informed and engaged with the latest developments in brain injury awareness and support services.

#### **Enquiries**

BIAT continues to be the primary point of contact for Tasmanians living with, or impacted by, brain injury.

Over the reporting period, we handled more than 118 enquiries, requiring dedicated follow-up and response. These figures underscore the critical demand for a Tasmanian-specific information and referral service for individuals impacted by brain injury. Our team remains well-connected, knowledgeable, and fully equipped to provide timely, accurate assistance to the community.

# **Community Events**

#### Larapinta End to End

In January, BIAT hosted a screening of Larapinta: End to End, a film that follows four Tasmanians with disabilities as they embark on a 17-day trek. The event drew a crowd of 40 attendees and concluded with an engaging Q&A session featuring Paul Pritchard, Melinda Oogjes, and Paul Allen.

Our team who attended the screening found the film's message deeply impactful, particularly its exploration of the "dignity of risk." One key takeaway was how the film conveyed that taking risks, is an essential part of living a full life.

The National Assistance Card were one of the sponsors for the production of the film.



### Information and Education Sessions Mary Mallett

In February, BIAT held its first Information and Education Session with Mary Mallett, Interim Disability Commissioner. Mary outlined the Office's early work, including clarifying the Commissioner's role, identifying resources, shaping a legislative framework, and building stronger connections with statutory offices and Tasmania's disability community.

Jessica Trevena

In April, BIAT welcomed Jessica Trevena, Clinical Neuropsychologist, Occupational Therapist, Lecturer at Monash University, and researcher at the Monash Epworth Rehabilitation Research Centre. Jess shared her clinical experience in rehabilitation after brain injury and her research on evidence-based approaches to improve recovery and long-term outcomes for people with brain injury and their families.

# National Brain Injury Awareness Week 2024

National Brain Injury Awareness Week is a key campaign that raises public awareness of brain injury and its impact on individuals, families, and the broader community.

In 2024, BIAT adopted the theme Strength in Stories, highlighting the lived experiences of people with brain injury through video, written word, and artwork. The week commenced with a launch event at the Moonah Arts Centre, attracting nearly 60 attendees our largest turnout to date. The event featured a pop-up art gallery showcasing artworks and stories developed through the Hear My Voice zine project, in collaboration with individuals in the community and the Risdon Prison Complex.

Throughout the week, BIAT shared personal stories across various platforms, including:

- A featured video on the use of the National Assistance Card.
- An online Q&A session with Alexis Bull, Rehabilitation Coordinator at the Royal Hobart Hospital.
- Videos highlighting the perspectives of individuals involved in the Employ Me Project and a partnership with the University of Tasmania.

Recordings and video content were made available through BIAT's social media channels. The shared stories deepen public understanding of life after brain injury.



## National Assistance Card Service

#### **About the Card**

The National Assistance Card is a personalised card that helps people with disability and health conditions communicate their unique areas of difficulty and support needs. The Card is currently available to Autistic people and people with brain injury in Australia. The Card is also being trialled with people with cognitive impairment who are participants in BIAT's JustACE Program.

The National Assistance Card Service hopes that in the future the Card will be available to all people with disability and health conditions in Australia. The National Assistance Card Project is funded by the Australian Government Department of Social Services.



### **National Assistance Card**

#### Raising Awareness of the Card

This year, the National Assistance Card team continued to build awareness of the Card among businesses, organisations, service providers, and the broader community. The team delivered 14 information sessions across all eight states and territories and had eight information stalls at events, including the Brain Injury Conference (SA), ATSA Independent Living Expo (TAS), the Disability Connection Expo (QLD), and the Broadmeadows Community Disability Expo (VIC).

### National rollout of the Card with Autistic people and autism community

In partnership with Amaze, a leading autism advocacy organisation, the National Assistance Card officially launched its national rollout to Autistic people in May 2025.

This milestone follows consultation with the Autistic community and a successful trial in Tasmania. The Card is designed to improve understanding of the communication barriers and everyday challenges Autistic people may face, and to support more inclusive interactions in the community.

The launch event held in Melbourne brought together cardholders, people with disability, service providers and community members in person and online. Tasmanian Senator Catryna Bilyk, a long-time supporter of the National Assistance Card, formally launched the Card for Autistic people nationwide. The event also featured a panel discussion with speakers with lived experience.

#### Feedback on the Card

A lived experience panellist, who is a National Assistance Card Steering Group member and Autism Connect Team Leader, shared how the Card could make a difference for Autistic people in everyday scenarios — from visiting the local pharmacy, to living in student accommodation, to building confidence to attend a peer support group.

This belief was supported by feedback from a cardholder attending the launch online who described the change they had experienced since receiving their Card:

🔍 I wanted to say thank you from the bottom of my heart for this Card. I sometimes run away and have meltdowns, and the police are sometimes involved. Since having the Card, my interactions with them have all been positive. The Card has helped de-escalate the situation and helped me get the support I need.



# JustACE Program

The JustACE program provides specialised support to individuals with cognitive impairment who are involved in the Tasmanian justice system as defendants/offenders. It is the only program of its kind in the state.

Using a through-care model, JustACE walks alongside participants from court involvement and custodial sentences through to community reintegration.

The program addresses service gaps by offering non-diagnostic cognitive assessments, individual planning and case management, and brain training activities to strengthen cognitive skills.

The program also delivers education and outreach across Tasmania to build understanding of cognitive impairment and improve referral pathways. To further support participants, planners specifically designed for people with cognitive impairment were distributed to help build routines and self-management skills. A total of 146 copies were provided to the Risdon Prison Complex, with additional copies made available through community corrections and to the wider community.

Stakeholders, including the Tasmanian Prison Service, Community Corrections, health services, and advocacy groups, also benefited from JustACE education sessions, training opportunities, and collaborative initiatives.

Feedback has been overwhelmingly positive, with participants reporting increased confidence, greater insight, and improved decision-making skills, while justice professionals have acknowledged the program's effectiveness in supporting individuals with complex needs.

### **JustACE Program**

#### **Hunter's story**

Hunter, a 39-year-old man with multiple brain injuries, had a long history of justice system involvement. His memory and cognitive challenges made attending court and managing daily life extremely difficult. Since joining JustACE, he has been supported to attend court, access medical care, secure ID, and begin the process of applying for the NDIS and Disability Support Pension. Hunter shared that JustACE is the first service that hasn't given up on him, stating: "I finally feel supported and seen."

#### **Reintegration Puzzle Conference**

Two JustACE staff members attended the 18th Reintegration Puzzle Conference in Mparntwe/Alice Springs. The team were able to learn more about returning to the community after prison.

# Employ Me and About Me Projects

The Employ Me Project utilises a 10 step process to support people living with brain injury in their employment journey. Participants have the option of recording a video that communicates their strengths, work history and support needs to employers. Employ Me has been adapted to the Empowered Me program by our project partner, the Association for Children with Disability (ACD Tasmania) to support young people with disability.

#### **Events**

#### **Outcomes**

### **About Me Project**

The About Me Project commenced in 2024. It builds upon the Employ Me model to offer three further modules: Health, Disability Support and Education. About Me supports people with disability in Tasmania to identify and communicate their strengths and needs in these areas of life. The About Me Project is funded by Tasmania's Motor Accident Insurance Board (MAIB). About Me has connected with dozens of stakeholders, including: MAIB, UTas, Road Trauma, Northern Support School and other schools, Tasmania-wide network of Allied Health providers including Speech Pathologists, Occupational Therapists, Integrated health services and General Practice.

#### **Outcomes**

- Two new modules developed
- Delivery of modules has begun
- Three participants engaged and interest growing in new modules yet to be released

#### **Case Study**

#### Association for Children with Disability's Empowered Me Program

The Association for Children with Disability Tasmania (ACD Tas) has developed the Empowered Me adaptation of the Employ Me program. Empowered Me is designed by young people with disability for young people with disability.

Jules (pseudonym) undertook the Empowered Me worksheets in 2022 but did not finish them. They then completed College and Year 13 and had NDIS support in seeking fulfilling work aligned with their interests. They volunteered in a few workplaces, contributed to ACD Tas consultations, however they did not achieve ongoing paid work.

In 2024, Jules approached the Empowered Me team to re-visit the program. They had an easy relationship and open communication with a Youth Connector. Jules re-engaged with other ACD Tas opportunities. Their warm, outgoing personality and openness to feedback contributed to the success of the group, while also giving them transferable work skills and boosting their confidence.

Empowered Me has given Jules the structure and focus to move toward a rewarding career that aligns with their values and to maximise their future supports.



# Treasurer's Report

I have the pleasure in presenting the Treasurer's Report for the Brain Injury Association of Tasmania (BIAT) for the year 1 July 2024 to 30 June 2025, and in confirming the financial performance for the fiscal year was in accordance with the budget approved by the BIAT Committee of Management.

The Financial Report and Auditor's Report are provided as separate documents. The audited Financial Statement shows a surplus position in the 2024-25 Financial Year. Both Commonwealth funded (Department of Social Services) Information Linkages and Capacity Building (ILC) Projects, the National Assistance Card (Individual Capacity Building- Recognise, Respect, Respond and Reform) and the Employ Me Project (Economic Participation Program) were finalised on 30 June, with all funding acquitted. The Tasmanian Department of Justice provided funding to enable the continuation of the JustACE program throughout 2024-25. The Motor Accident Insurance Board (MAIB) also funded the About Me Project and the Brain Injury-Making a Difference activity. Surplus funding received in the financial year has been recorded as grants in advance in the Balance Sheet. It is fully committed to future project activity.

The Statement of Financial Position shows BIAT's accumulated funds (reserves) of \$270,012. The BIAT Committee of Management remains conscious of the need for a solid financial position to buffer the organisation from future financial risks. Its focus on good financial management encompasses the need to ensure that BIAT can meet all potential liabilities and remains financially sustainable.

Income and expenditure were higher than the previous year as a result of an increase in program activity to complete projects which were funded to 30 June 2025. BIAT has been fully funded to continue our current Commonwealth Government ILC projects in 2025-26. These include both the National Assistance Card and Employ Me which will now be funded under the Department of Health, Disability and Ageing. We are happy to announce that these ILC Grant extensions are now formally transitioned to 'Foundational Supports' for both projects.

Due to the early and unexpected state election, the Department of Justice provided funding for the JustACE Program for three months under the budget supply bill. BIAT is working closely with the Department to ensure funding continues for the full 12-month period when the Tasmanian Government budget is handed down.

# Treasurer's Report

MAIB renewed their funding for the About Me Project for another 12-months, and BIAT's new Information and Awareness Project for three (3) years, ensuring community engagement activities such as Information and Referral services, Peer Support and Custody for Life programs will continue until 2028.

The cash position, along with the organisation's reserves and the grant funding received for 2025-26, are the basis for the Committee of Management declaration in the audit report that BIAT can meet its debts as they fall due.

In closing I would like to take this opportunity to thank the Australian Government Department of Social Services, Tasmanian Government Department of Justice and the Motor Accident Insurance Board for their ongoing support of the work of BIAT.

### BRAIN INJURY ASSOCIATION OF TASMANIA INC. NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30TH JUNE 2025

#### NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

This financial report is a special purpose financial report that has been prepared in accordance with Australian Accounting Standards and other mandatory professional reporting requirements and the requirements of the Associations Incorporation Act (1964). The financial report is prepared on an accruals basis and is based on historical costs and does not take into account changing money values or, except where stated, current valuations of non-current assets.

Cost is based on the fair values of the consideration given in exchange for assets. The accounting policies have been consistently applied, unless otherwise stated.

The following is a summary of the material accounting policies adopted by the association in the preparation of the financial report:

#### a) **EQUIPMENT**

Equipment is recorded at cost. The depreciable amounts of capitalised fixed assets are depreciated over their useful lives to the association, commencing in the year of acquisition. The straight line and reducing balance methods of depreciation are used. The recoverable amount is assessed on the basis of the expected net cash flows which will be received from the assets employment and subsequent disposal. The expected net cash flows have not been discounted to present values in determining the recoverable amount. The gain or loss on disposal of all fixed assets is determined as the difference between the carrying amount of the asset at the time of the disposal and the proceeds of the disposal, and is included in the operating profit of the association in the year of disposal.

#### b) PROVISIONS FOR EMPLOYEE ENTITLEMENTS

Provision is made for the Associations' liability for employee entitlements arising from services rendered by employees to balance date. Employee entitlements expected to be settled within one year together with entitlements arising from wages and salaries and annual leave which will be settled after one year have been measured at their nominal amount. Long service leave is accrued when the employee reaches 5 years of service.

#### c) SUPERANNUATION

Contributions are made to the employee superannuation funds in accordance with the requirements of the Superannuation Guarantee Levy.

#### d) INCOME TAX

The Association is exempt from income tax.

#### e) CASH

Cash includes cash at bank and on deposit.

#### f) REVENUE

When the Association receives operating grant revenue, donations or bequests, it assesses whether the contract is enforceable and has sufficiently specific performance obligation:

When both of these conditions are satisfied, the Association:

- identifies each performance obligation relating to the grant
- recognises a contract liability for its obligations under the agreement
- recognises revenue as it satisfies its performance obligations.

Where the contract is not enforceable or does not have sufficiently specific performance obligations, the Association:

- recognises the asset received in accordance with the recognition requirements of other applicable accounting standards (eg AASB 9, AASB 16, AASB 116 and AASB 13)
- recognises related amounts (being contributions by owners, lease liability, financial instruments, provisions, revenue or contract liability arising from a contract with a customer)
- recognises income immediately in profit or loss as the difference between the initial carrying amount of the asset and the related amount.

If a contract liability is recognised as a related amount above, the Association recognises income in the profit or loss when or as it satisfies its obligations under the contract.

Interest revenue is recognised on a proportional basis taking into account the interest rates applicable to the financial assets.

#### g) GOODS & SERVICES TAX (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the Statement of Financial Position are shown inclusive of GST.

#### h) **LEASES**

Lease payments under operating leases, where substantially all the risks and benefits remain with the lessor, are charged as expenses in the periods in which they are incurred.

#### i) **UNEXPENDED GRANTS**

Unexpended grants reflect the timing difference between the receipt of grant funds and meeting the obligations of the grant funds. Unexpended funds where the program has been concluded or near conclusion reflect either the cost to be incurred in the next financial year to conclude the grant funded project or monies that may be returned to the funder. The unexpended grants balance reflects costs that have been or will be incurred in the 2025 financial year or to wind up the projects at completion.

#### NOTE 2: EVENTS SUBSEQUENT TO REPORTING DATE


