1. Registration and Payment Terms

All ticket prices are quoted in Euros (EUR) and exclude 23% Portuguese VAT and other service fees.

Payment must be completed through our [official Eventbrite platform](#).

- Early Bird tickets (€1000) are available until September 1, 2025;
- General Admission (€1500) from September 2 to October 1, 2025;
- Last Call tickets (€2000) beginning October 2, 2025 to October 21, 2021.

Unpaid registrations after deadline dates will automatically convert to the next pricing tier.

The ticket entitles the holder to access to all sessions at FHIR Camp 2025, two coffee breaks and one lunch during the event hours, event materials and photography services.

The ticket **does not include** hotel accommodation, airfare, airport transfers, meals outside of the scheduled breaks, or any other expenses not expressly stated herein.

2. Cancellation and Refund Policy

Cancellation requests must be submitted in writing to Svetlana Golubeva at the email address above no later than October 15, 2025.

Approved cancellations will receive a refund of the ticket price minus 23% VAT, processed within 30 calendar days. No refunds will be issued for no-shows or cancellations after October 15, 2025.

The Organizer reserves the right to cancel or reschedule the event due to unforeseen circumstances. In such cases, participants will receive a full refund of the ticket price within 10 business days.

3. Complimentary Ticket Program

A limited number of complimentary tickets are available. Applicants must submit their LinkedIn profile and a cover letter (minimum 300 words) detailing their professional background, learning objectives, and potential contributions to FHIR Camp.
