## 2nd Readings and Final Reading

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 51 OF THE CODE OF THE CITY OF HOBOKEN ENTITLED "MAYOR, OFFICE OF" AT § 51-1 "CREATION OF OFFICE; DIRECTOR; STAFF" TO ADD A PROVISION FOR OUTSIDE EMPLOYMENT (B-49)

**NOW, THEREFORE**, the City Council of the City of Hoboken does hereby Ordain as follows (<u>additions noted in underline</u>, <u>deletions noted in strikethrough</u>):

SECTION ONE: AMENDMENT TO HOBOKEN CODE CHAPTER 51 TO ADD §51-1(C)

§ 51-1 Creation of Office; Director; Staff.

- A. Creation. There is hereby created the office of the Mayor, which shall be headed by the Mayor, who shall serve as director without any additional compensation, and shall consist of his personnel staff.
- B. Personnel staff. The personnel staff in the Office of the Mayor shall include a Secretary, Clerk-Stenographer and Confidential Aide.
- C. Outside Employment. While the Office of the Mayor is a full-time position, the Mayor may be employed in other governmental or private sector employment, except not within the City of Hoboken government, so long as such employment does not compromise the Mayor's ability to fulfill the duties of the office and as long as all related income are publicly disclosed. To ensure that such outside employment does not create a conflict with the Mayor's full time duties, public disclosure of such income shall include the name of the employer, the amount of all compensation, including commissions, and in the case of private sector employment, a quarterly listing of all clients and/or contracts. This reporting must be made to the City Clerk no later than ten business days following the close of each quarter.

## SECTION TWO: REPEAL OF INCONSISTENT PROVISIONS

All ordinances or parts thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only to the extent of such conflict or inconsistency, it being the legislative intent that all such ordinances or part of ordinances now existing or in effect unless the same are in conflict or inconsistent with any provision of this Ordinance shall remain in effect.

## **SECTION THREE: SEVERABILITY**

The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason be held to be invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, but shall remaining in effect; it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

## SECTION FOUR: EFFECTIVE DATE

This Ordinance shall take effect immediately upon passage and publication as provided by law.

#### **SECTION FIVE: CODIFICATION**

This ordinance shall be a part of the Code of the City of Hoboken as though codified and fully set forth therein. The City Clerk shall have this ordinance codified and incorporated in the official copies of the Code.

The City Clerk and the Corporation Counsel are authorized and directed to change any Chapter, Article and/or Section number of the Code of the City of Hoboken in the event that the codification of this Ordinance reveals that there is a conflict between the numbers and the existing Code, and in order to avoid confusion and possible accidental repealers of existing provisions not intended to be repealed.

ORDINANCE AMENDING HOBOKEN CITY CODE CHAPTER 190 "VEHICLES AND TRAFFIC" ARTICLE XXXIII "BICYCLE RULES AND REGULATIONS" TO CREATE A SET FINE FOR PARKING IN BICYCLE LANES SO THAT A COURT APPEARANCE IS NOT MANDATORY (B-63) (COUNCIL MEMBER CUNNINGHAM, COUNCIL MEMBER RAMOS)

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF HOBOKEN DOES HEREBY ORDAIN AS FOLLOWS (ADDITIONS NOTED IN UNDERLINE, DELETIONS NOTED IN STRIKETHROUGH):

SECTION ONE: AMENDMENTS TO HOBOKEN CODE CHAPTER 190, ARTICLE XXXIII.

## **ARTICLE XXXIII Bicycle Rules and Regulations**

## § 190-46 Scope.

The provisions of this section shall apply whenever a bicycle is operated upon any street or upon any public way within the City of Hoboken, subject only to those exceptions stated in this section.

## § 190-47 Streets Designated.

- A. Street segments with sufficient adjacent right-of-way shall be considered acceptable for installation of Class I bicycle lanes physically separated from the street consisting of a five-foot-wide bicycle lane per travel direction demarcated with solid white lane striping and yellow striping bifurcating opposing bicycle travel lanes; these lanes shall include standard bicycle symbols painted on the street and optional contrast coloring within the bike lanes clearly indicating the space as a bicycle lane.
- B. Streets segments with a travel lane of 15 feet or greater shall be considered acceptable for installation of Class II bicycle lanes consisting of a five-foot-wide bicycle lane demarcated with solid white line lane striping; these lanes shall include standard bicycle symbols painted on the street and optional contrast coloring within the bike lanes clearly indicating the space as a bicycle lane.
- C. Streets segments with a travel lane of less than 15 feet or with traffic patterns that make Class I or II bicycle lanes impractical, shall be considered acceptable for installation of Class III bicycle route markings consisting of standard bicycle symbols and double chevrons, also known as sharrows, painted on the street to communicate that drivers shall share the road with bicyclists; these routes shall also include "share the road" posted signage.

- D. Street designations and typical lane configurations are meant to be standard guidelines; however, all final bicycle lane and route configurations are subject to professional review and recommendation by the department of transportation and parking and shall be included in the city code.
- E. The following roadways are hereby designated as bicycle lanes and/or routes.
- \*Takes effect immediately upon substantial completion of the observer highway complete streets redesign.

# § 190-48 Lane Configuration.

- A. Class I bicycle lanes shall be separated from vehicle traffic by a curb or median.
- B. Class II bicycle lanes shall be located on the right side of two-way streets and the left side of one-way streets, between parking and travel lanes.
- C. Class III bicycle routes shall offset markings to the right of the travel lane center line so that bicyclists are guided outside of the door sweep area of parked cars.
- D. Appropriate striping, pavement markings, and/or signage shall be used at intersections where streets transition between one-way and two-way traffic flow.

## § 190-49 Application of Traffic Laws To Bicycles.

Every person riding a bicycle upon a roadway shall be granted all the rights and shall be subject to all the duties applicable to the driver of a vehicle by the laws of this state and the traffic provisions of this code applicable to the driver of a vehicle, except as to special regulations in this article and except as to those provisions of laws and ordinances which by their nature are inapplicable to such persons.

## § 190-50 Bicycle Rules and Regulations.

- A. Obedience to traffic control devices.
- (1) Any person operating a bicycle shall obey the instructions of official traffic control signs, and other control devices applicable to vehicles, unless otherwise directed by a police officer.
- (2) Whenever authorized signs are erected indicating that a turning movement is restricted no person operating a bicycle shall disobey the direction of any such sign, except where that person dismounts from the bicycle to make the turn, in which event such person shall then obey the regulations applicable to pedestrians.
- (3) No person shall ride or operate a bicycle in any direction except that permitted of vehicular traffic traveling on the same side of the roadway.
- (4) Any person operating a bicycle shall stop for pedestrians in crosswalks.
- B. Riding on roadways and bicycle paths generally.
- (1) Every person operating a bicycle upon a roadway shall ride as near to the right hand side of the roadway as practicable, exercising due care when passing a standing vehicle or a vehicle proceeding in the same direction, unless an exclusive bicycle lane is provided.
- (2) Persons riding bicycles upon a roadway shall not ride more than two abreast except on paths or parts of roadways set aside for the exclusive use of bicycles.

- (3) Whenever a bicycle lane has been established on a roadway, any person operating a bicycle upon the roadway at a speed less than the normal speed of traffic moving in the same direction shall ride within the bicycle lane, except that such person may move out of the lane under any of the following situations:
- (a) Whenever overtaking or passing another bicycle, vehicle or pedestrian within the lane or about to enter the lane if such overtaking and passing cannot be done safely within the lane.
- (b) When preparing for a turn at an intersection or into a private road or driveway.
- (c) When reasonably necessary to leave the bicycle lane to avoid debris or other hazardous conditions.
- C. Manner of riding bicycle.
- (1) A person propelling a bicycle shall not ride other than astride a permanent and regular seat attached thereto.
- (2) No bicycle shall be used to carry more persons at one time than the number for which it is designed and equipped.
- D. Speed restrictions. No person shall operate a bicycle at a speed greater than is reasonable and prudent under the condition then existing.
- E. Yielding right-of-way from bicycle path or sidewalks. Every person riding a bicycle on a bike path or sidewalk that is about to enter or cross a roadway shall yield the right-of-way to all traffic on such roadway.
- F. Leaving bicycle lanes. No person operating a bicycle shall leave a bicycle lane until the movement can be made with reasonable safety and then only after giving an appropriate signal.
- G. Motor vehicles in bicycle lanes. Whenever a bicycle lane has been established on a roadway any person operating a motor vehicle on such a roadway shall not drive or park in the bicycle lane except for the purposes of performing a parking maneuver where parking is permitted, to enter or leave the roadway, or to maneuver around a parked vehicle impeding traffic flow.
- H. Bicycles emerging from alleys or driveways; yielding right-of-way. The operator of a bicycle emerging from an alley, driveway, or building, shall, upon approaching a sidewalk area extending across any alleyway or driveway, yield the right-of-way to all pedestrians approaching on the sidewalk or sidewalk area. Upon entering the roadway the operator shall yield the right-of-way to all vehicles approaching on the roadway.
- I. Clinging to vehicles prohibited. No person riding upon any bicycle shall attach the same or himself to any streetcar or vehicle upon a roadway.
- J. Riding on sidewalks.

- (1) No person shall ride a bicycle upon a sidewalk at a speed greater than the walking speed of pedestrians.
- (2) Persons riding a bicycle upon a sidewalk shall yield the right-of-way to any pedestrian and shall give an audible signal before overtaking and passing any pedestrian.
- (3) Persons riding a bicycle upon a sidewalk shall keep as close to the curb as is practicable to allow pedestrians to walk along sidewalks without impedance.
- K. Carrying articles. No person operating a bicycle shall carry any package, bundle, or article which prevents the rider from keeping at least one hand upon the handlebars.
- L. Parking. No person shall park a bicycle upon a street other than upon the roadway against the curb or in a designated bicycle parking area or upon the sidewalk in a rack to support the bicycle, or against a building or at the curb in such manner as to afford the least obstruction to pedestrian traffic.
- M. Lamps and equipment on bicycles.
- (1) Bicycles in use at nighttime shall be equipped with a lamp on the front which shall emit a white light visible from a distance of at least 500 feet to the front and with a red reflector on the rear of a type which shall be visible from 50 feet to 300 feet to the rear. A lamp emitting a red light visible from a distance of 500 feet to the rear may be used in addition to the red reflector.
- (2) A bicycle shall not be equipped with, nor shall any person use, any siren or whistle upon a bicycle.
- (3) Bicycles shall be equipped with a brake which will enable the operator to make the braked wheel skid on dry, level, clean pavement.
- (4) Bicycles may be equipped with a bell to serve as audible signal for the purposes of overtaking and passing any pedestrian or other bicycles.
- N. Bicycle parking, generally.
- (1) Bicycles are permitted to be secured at the bicycle racks in the city for up to seven consecutive days without being utilized.
- (2) Bicycles may be attached or secured to the bicycle rack with a u-lock, chain lock, or any other type of lock that is made specifically for bicycles. No person shall attach or secure a bicycle to any fixed object not suited for bicycle parking. No person shall leave a bicycle lying on or standing upon the sidewalk in such a manner so as to hinder or impede pedestrians.
- O. Abandonment of bicycles, generally.
- (1) A bicycle may be deemed abandoned by the city if:
- (a) It has been parked for a period of seven or more consecutive calendar days in the same location; or

- (b) It appears visually to be in a state of prolonged disuse such that it has deflated tires, a rusted chain, accumulated leaves and debris associated with it, bent or missing wheels, bent handlebars, or other missing parts; or
- (c) Seventy-five percent or more of the bicycle is rusted; or
- (d) It is found in any other condition in which a bicycle would be deemed to be abandoned.
- (2) It shall be unlawful for any person to abandon any bicycle within the city.
- (3) In the event that a bicycle is deemed to be abandoned by the city's transportation and parking department, the department shall have the authority to place an abandoned bicycle notice, in the form of an adhesive sticker, on the bicycle itself to notify the owner that said bicycle is deemed to be abandoned pursuant to this subsection and that it will be removed and disposed of if not moved.
- (4) The notice in the form of an adhesive sticker shall state the following:
- (a) The date after which the bicycle may be removed if the owner/user does not remove and reclaim it; and
- (b) The name and contact information for a city representative to contact in case the bicycle has been mistakenly identified as abandoned.
- (5) Once an abandoned notice sticker has been placed on a bicycle, the owner of the bicycle shall have 14 calendar days as set forth on the notice sticker to remove the bicycle from the location. If it is not removed within the fourteen-calendar-day notice period as provided on the sticker, it may thereafter be removed from its location by any means necessary and disposed of by the city in accordance with the law.

#### § 190-51 Other Users of Bicycle Lanes.

In addition to bicycle riders, individuals using roller blades, motorized wheelchairs with an orange safety flag at least five feet above street level, and bicyclers with attached trailers for children will also have the same orange safety flag attached to the rear of the portage vehicle, shall also be permitted to use the bicycle lanes.

## § 190-52 Penalties.

In the event that any individual violates the terms of this section he/she shall be subject to a fine in the municipal court of the City of Hoboken in an amount of \$100 for the first offense and \$200 per violation for any subsequent offenses.

AN ORDINANCE AMENDING CHAPTER 190 ENTITLED "VEHICLES AND TRAFFIC" TO AMEND PARKING VIOLATIONS AND PENALTIES (B-64)

AN ORDINANCE AMENDING THE HOBOKEN CITY CODE AT CHAPTER 190 "VEHICLES AND TRAFFIC" ARTICLE XVII ENTITLED "METERED AND PAY STATION PARKING" TO IMPLEMENT DYNAMIC PRICING FOR METERS (B-65)

**WHEREAS**, Chapter 190 Article XVII of the General Code of the City of Hoboken establishes the rules, time limits, and tariff schedules associated with the City's on-street paid parking zones; and,

WHEREAS, on-street parking rates have not changed in Hoboken in over 10 years; and,

**WHEREAS**, best practice in parking policy calls for adjusting the price of curbside parking to achieve an 85 percent occupancy rate, which will result in one-to-two parking spaces being available on each block; and,

**WHEREAS**, the Parking Master Plan completed in 2014 recommends adjusting curbside parking rates to encourage more turnover and increased garage utilization; and,

**WHEREAS**, the Parking Master Plan also recommends implementing "dynamic pricing" that varies curbside parking rates based on factors such as parking demand, adjacent land uses, or peak periods; and,

**WHEREAS**, dynamic pricing has been shown in other cities to increase parking turnover at higher rates in higher parking demand areas, which improves access to nearby brick and mortar businesses; and,

**WHEREAS**, dynamic pricing will help decrease traffic resulting from circling looking for street parking; and,

**WHEREAS**, increased revenues generated from the implementation of dynamic pricing shall be reinvested into various economic development initiatives within a new "Parking Benefit District", including streetscape improvements such as lighting, benches, landscaping, and improved signage; infrastructure improvements such as sidewalk replacement, paving, and safety enhancements; and a new "Shop Hop" historic trolley bus service that will serve Hoboken business districts.

**NOW, THEREFORE**, the City Council of the City of Hoboken does hereby Ordain as follows (<u>additions noted in underline</u>, <u>deletions noted in strikethrough</u>):

SECTION ONE: AMENDMENTS TO HOBOKEN CODE CHAPTER 141.

§ 190-29.8 Time limit location parking and fees.

In accordance with the provisions of this Article XVII, no person shall park or stand a vehicle for longer than the time limit posted upon any of the herein described streets or parts of streets, subject only to the exceptions and conditions in § 190-29.9:

AN ORDINANCE AMENDING CHAPTER 141 "PARKING GARAGES AND LOTS, PUBLIC", TO AMEND MONTHLY AND TRANSIENT PARKING RATES IN MUNICIPAL PARKING FACILITIES (B-66)

**WHEREAS**, the Parking Master Plan completed in 2014 recommends adjusting transient parking rates to better balance short term parking pricing with on-street parking rates; and,

**WHEREAS**, monthly parking rates in City of Hoboken owned garages and lots are approximately 30 percent below market rate; and,

**WHEREAS**, monthly parking rates in City of Hoboken owned garages and lots have not been changed in over 10 years; and,

**WHEREAS**, a lack of rate increases during the previous 10-plus years has left the Hoboken Parking Utility with limited resources available to pay for facilities maintenance, replacing obsolete parking access and revenue control systems, etc.; and,

**WHEREAS**, this ordinance will modernize monthly parking rates, and additional revenues generated from price increases will be reinvested into improvements to off-street municipal parking facilities, including maintenance and repairs, modernizing parking access and revenue control systems,

### SECTION TWO: REPEAL OF INCONSISTENT PROVISIONS

All ordinances or parts thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only to the extent of such conflict or inconsistency, it being the legislative intent that all such ordinances or part of ordinances now existing or in effect unless the same are in conflict or inconsistent with any provision of this Ordinance shall remain in effect.

#### **SECTION THREE: SEVERABILITY**

The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason be held to be invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, but shall remaining in effect; it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

## SECTION FOUR: EFFECTIVE DATE

This Ordinance shall take effect immediately upon passage and publication as provided by law.

## **SECTION FIVE: CODIFICATION**

This ordinance shall be a part of the Code of the City of Hoboken as though codified and fully set forth therein. The City Clerk shall have this ordinance codified and incorporated in the official copies of the Code.

The City Clerk and the Corporation Counsel are authorized and directed to change any Chapter, Article and/or Section number of the Code of the City of Hoboken in the event that the codification of this Ordinance reveals that there is a conflict between the numbers and the existing Code, and in order to avoid confusion and possible accidental repealers of existing provisions not intended to be repealed.

# THE MAYOR AND COUNCIL OF THE CITY OF HOBOKEN DOES HEREBY ORDAIN AS FOLLOWS:

<u>Section 1:</u> The following deletions shall be made to Chapter 192 of the Code of the City of Hoboken entitled "Parking for Persons with Disabilities" §192-4 entitled "Enumeration of Spaces" to approve the removal of restricted handicapped parking spaces as follows:

Gloria Suarez 1302 Washington Street (west side of Washington Street, beginning at a point 35 feet from the northerly curbline of Thirteenth Street and extending 12 feet northerly therefrom)

Megan Reynders 711 Willow Avenue east side of Willow Avenue, beginning at a point 155 feet north of the northerly curbline of Seventh Street and extending 22 feet northerly therefrom

Steve Cappiello 530 Adams Street (west side of Adams Street beginning at a point 355 feet north of Fifth Street and extending 22 feet north therefrom)

Margarita Obolesheva 1035 Bloomfield Street (east side of Bloomfield Street, beginning at a point 305 feet north of the northerly curbline of Tenth Street and extending 22 feet northerly therefrom)

Michele Spina 912 Garden Street (west side of Garden Street, beginning at a point of 270 feet south of Tenth Street and extending 22 feet southerly therefrom)

#### SECTION TWO: REPEAL OF INCONSISTENT PROVISIONS

AN ORDINANCE AMENDING CHAPTER 68 OF THE HOBOKEN CITY CODE ENTITLED "ALCOHOLIC BEVERAGES" AT §68-7G TO ESTABLISH A PROCEDURE FOR PETITIONING THE CITY COUNCIL FOR AN EXCEPTION TO THE 500 FOOT RULE (B-69) (COUNCIL MEMBER DOYLE)

**WHEREAS**, pursuant to Hoboken City Code § 68-7G, "any person owning, or under contract or option to purchase, a plenary retail consumption license may petition the City Council for an exception to the rule prohibiting a transfer to be made to other premises within a distance of 500 feet from any other premises then covered by a plenary retail consumption license..."; and,

**WHEREAS**, this legislation is necessary to establish a procedure for the hearing of such requests for an exemption before the City Council.

# THE MAYOR AND COUNCIL OF THE CITY OF HOBOKEN DOES HEREBY ORDAIN AS FOLLOWS:

**SECTION 1:** The following <u>additions</u> and <u>deletions</u> shall be made to Chapter 68 "Alcoholic Beverages" as follows:

#### § 68-7. Five-Hundred-Foot Rule.

A. Except as set forth in Subsection F of this section, no plenary retail consumption license without broad package privileges (License Type 33), except renewals for the same licensed premises and transfers of license from person to person within the same premises, shall be granted or transfer made to other premises within a distance of 500 feet from any other premises then covered by a plenary retail consumption license without broad package privileges (License Type 33). Should a license held by a restaurant be transferred to another location for use as a tavern, the restriction promulgated herein shall apply.

B. No plenary retail consumption license with broad package privileges (License Type 32), except renewals for the same licensed premises and transfers of license from person to person within the same premises, shall be granted or transfer made to other premises within a distance of 500 feet from any other premises then covered by a plenary retail consumption license with broad package privileges (License Type 32). There shall be no exceptions to this restriction. Should a license held by a restaurant be transferred to another location for use as a tavern, the restriction promulgated herein shall apply.

- C. No plenary retail distribution license, except renewals for the same premises and transfers from person to person, shall be granted or transfer made to other premises within a distance of 500 feet from any other premises then covered by a plenary distribution license.
- D. Where the five-hundred-foot distance is referred to in this section, the same shall be measured by a distance from the center of the entrance door of an existing tayern to the center of the entrance door of a proposed licensed premises as measured by walking along the sidewalk from point to point without any diagonal crossing of streets. If it is necessary to cross a street, such steps are to be taken at the lawful crosswalks in a direct manner. The local license issuing authority may, in its discretion, grant a transfer of an existing license to the same licensee to other premises within 250 feet of the premises from which the transfer is made, notwithstanding that the premises to which the license is so transferred is within 500 feet of an existing plenary retail consumption licensed premises, and grant transfer of such license free of such five-hundred-foot limitation herein fixed in the event of any licensed premises being taken by condemnation for any municipal, county, state or federal project; provided, nevertheless, that the new location to which the license is to be transferred under this exception shall not be located within a distance of 250 feet of a then-existing location licensed to do business under a like license as the one being transferred. Said two-hundred-fifty-foot distance shall be measured in the same manner as herein provided for the measuring of the five-hundred-foot distance. In the event that any transfer of a license should be allowed under this exception, then and in that event no license shall thereafter be transferred to the premises or any part thereof so vacated by such transfer, nor within a radius of 250 feet thereof; provided, however, that all other provisions of this chapter and applicable law relating thereto are complied with.
- E. "Restaurant," as defined in this section, shall mean an establishment regularly and principally used for the purpose of providing meals to the public, having an adequate kitchen and dining room equipped for the preparing, cooking and serving of food for its customers and in which no other business, except such as is incidental to such establishment, is conducted and where such premises shall conform to local and state fire and health codes.
- F. The following are exceptions to the five-hundred-foot rule prohibition set forth in Subsection A above:
- (1) The prohibition shall not apply to the Southern Redevelopment Area as defined in the "Hoboken City Code § 68-7 Five-Hundred-Foot Rule Map." However, in said area, the number of plenary retail consumption licenses shall be limited to seven.
- (2) The prohibition shall not apply to the area identified as the Central Business District as defined in the "Hoboken City Code § 68-7 Five-Hundred-Foot Rule Map." However, in said area, the number of plenary retail consumption licenses shall be limited to 25.

- (3) The prohibition shall not apply to the Neumann Leathers Redevelopment Area as defined in the "Hoboken City Code § 68-7 Five-Hundred-Foot Rule Map." However, in said area, the number of plenary retail consumption licenses shall be limited to three.
- (4) The prohibition shall not apply to the Western Edge Redevelopment Area as defined in the "Hoboken City Code § 68-7 Five-Hundred-Foot Rule Map." However, in said area, the number of plenary retail consumption licenses shall be limited to 10.
- (5) The prohibition shall not apply to the Southwest Redevelopment Area as defined in the "Hoboken City Code § 68-7 Five-Hundred-Foot Rule Map." However, the total number of plenary retail consumption licenses in said area shall be limited to five.
- (6) The prohibition shall not apply to the portion of Hoboken designated as the Third Ward in the "Hoboken City Code § 68-7 Five-Hundred-Foot Rule Map." However, the total number of plenary retail consumption licenses in said area shall be limited to 15.
- (7) The prohibition shall not apply to the portion of Hoboken designated as the First Ward in the "Hoboken City Code § 68-7 Five-Hundred-Foot Rule Map" that is not included in the Central Business District or the Southern Redevelopment Area, as those terms are defined in subsection E(2) and E(1), respectively, above. However, the total number of plenary retail consumption licenses in said area shall be limited to 10.
- (8) The prohibition shall not apply to any plenary retail consumption license designated as a theater exception "37" license in the City of Hoboken.
- G. Any person owning, or under contract or option to purchase, a plenary retail consumption license may petition the City Council for an exception to the rule prohibiting a transfer to be made to other premises within a distance of 500 feet from any other premises then covered by a plenary retail consumption license (as set forth in § 68-7A, above). If the petition is granted, the total number of plenary retail consumption licenses enumerated in Section F shall not change. Such an exception shall require six votes of the Council and only be granted based on the criteria of extraordinary circumstances. The procedure for review of petitions by the Council shall be as follows:
  - 1. The hearing may be held at any regular council meeting or a special council meeting.
  - 2. The City Council will act as the trier of fact and sit in a quasi-judicial capacity, and a member of the Council shall be designated as "chair" of the hearing.
  - 3. The petitioner will be consulted as to the date and time of the hearing and may be represented by an attorney.
  - 4. The petitioner may present testimony or other evidence on his or her behalf.

- 5. The petitioner and all of his or her witnesses shall swear or affirm to testify truthfully before giving any testimony.
- 6. The petitioner will enter his or her appearance and be sworn in by the City Clerk. If the applicant is represented by an attorney, the attorney shall enter his or her appearance and may proceed with an opening statement.
- 7. The petitioner shall provide the City Clerk in advance of the hearing with 12 copies of all documentary evidence or exhibits upon which the petitioner intends to rely or refer to during the hearing. The petitioner or his or her attorney shall then present the testimony of the petitioner's witness(s), which may include the petitioner.
- 8. After each witness concludes his or her testimony for the petitioner, members of the public may then pose questions to the witness related to the testimony provided by the witness. Each member of the public shall be limited to a total of five (5) minutes for questions unless otherwise allowed by the chair of the meeting. This time shall be limited to asking questions; members of the public shall not be permitted to make a statement regarding the petition at this juncture.
- 9. After the members of the public are done asking the witness questions, the City Council may then pose questions to the witness.
- 10. The procedures enumerated in subsections (8) through (9) apply for each of the petitioner's witnesses.
- 11. When all of the petitioner's witnesses have been presented, the Administration shall have the right to present evidence that is relevant to the petition. If the Administration chooses to rely on documentary evidence or exhibits during the hearing, it must provide the petitioner with a copy of the documentary evidence or exhibits in advance of the hearing as well as copies for the public to review at the hearing. The Administration shall also have the right to call witnesses to testify as to the particular facts of the petition. The procedure for each of the petitioner's witnesses, as set forth in subsections (8) through (9), shall be applicable to any Administration witness.
- 12. After all testimony is completed, the chair shall open the hearing for public comment. Members of the public may then issue comments or statements in favor of or opposition to the petition. Each member of the public shall be limited to a total of five (5) minutes to make a statement.
- 13. Once the public comment period has concluded, the petitioner or his or her attorney may then issue a closing statement. The duration of each witness' testimony elicited by petitioner and the closing statement will be determined by the chair, based in large part on the complexity of the petition and testimony.
- 14. The hearing will be closed after all parties who wish to be heard on the petition have been heard. The City Council will then deliberate the matter in public, followed by a motion and vote. The City Council's decision will be described in detail in a resolution,

adopted at either the same meeting or next scheduled meeting. The City Council may defer its decision to a subsequent council meeting; however, a decision must be rendered at one of the next two regularly scheduled council meetings. If the City Council defers its decision to a subsequent meeting, the petitioner will be notified of the date and time of said meeting.

## 18-608 B-70

AN ORDINANCE AMENDING ARTICLE I, CHAPTER 46 OF THE HOBOKEN CITY CODE ENTITLED "LEASE AGREEMENTS" AT § 46-8 TO AUTHORIZE THE MAYOR TO EXECUTE A LEASE WITH THE EASTERSEALS NEW JERSEY (B-70) (COUNCIL MEMBER DEFUSCO)

**WHEREAS**, <u>N.J.S.A</u>. 40A:12-14(c), authorizes a municipality to lease real property to a nonprofit corporation for a public purpose; and,

WHEREAS, pursuant to the Resolution Granting Preliminary Site Plan Approval, Conditional Use Approval and Variance Relief with Respect to the Property known as 1316-1330 Willow Avenue, Block 116, Lot 1.2, City of Hoboken, County of Hudson, State of New Jersey ("the Resolution") (attached hereto), dated January 19, 2010, the Zoning Board applicant Advance at Hoboken LLC ("Advance") was required to reserve approximately 1,000 square feet of ground floor space at the project site (now known as the "Harlow Building") for use by the City of Hoboken, either as a community use, or for another public use, to be determined by the City of Hoboken; and,

**WHEREAS**, pursuant to the transcript from the Zoning Board hearing wherein this condition was discussed, it was specifically contemplated that the City could allow a nonprofit organization to utilize this space; and,

**WHEREAS**, Hoboken has not previously utilized the above referenced 1,000 square feet of available space (hereinafter referred to as "the property"); and,

**WHEREAS**, the property is not currently needed for public use, and therefore Hoboken wishes to lease the property to a non-profit organization, the Easterseals, for a public purpose, in accordance with N.J.S.A. 40A:12-14 and 15; and,

**WHEREAS**, the Easterseals will utilize the property for the promotion of the health, safety, morals and general welfare of the community, specifically, by housing two workforce development programs, as follows:

1) SCSEP (Senior Community Services Employment Program): A community service and work-based program for older Americans. Participants also have access to employment assistance through the American Jobs Centers. SCSEP participants gain work experience in a variety of community service activities at non-profit and public facilities, including schools, hospitals, day-dare centers, and senior centers. Participants work an average of 20 hours a week, and are paid the highest of federal, state or local minimum wage. This training serves as a bridge to unsubsidized employment opportunities for participants. Participants must be at least 55 years of age, unemployed and have a family income of no more than 125% of the federal poverty level; and,

2) Supported Employment Program: Funded through the Department of Labor, the Supported Employment program assists people with disabilities in choosing, finding and maintaining competitive employment in an integrated setting. Employment Specialists use an individualized approach, matching the skills and abilities of the participants to the employer needs, which results in successful job matches. The goal is to empower participants with training and education so that they may achieve their maximum potential through increased independence, productivity, and work place integration.

**WHEREAS**, Hoboken has determined that the lease to the Easterseals will result in a significant benefit to the Hoboken community, particularly to senior citizens and citizens with disabilities; and,

**WHEREAS**, pursuant to the criteria enumerated in <u>N.J.S.A</u>. 40A: 12-14(c), Hoboken agrees to lease the property to the Easterseals New Jersey under the following conditions:

- 1. The consideration for the lease is \$1 per year payable each month in addition to required community outreach, as fully set forth in the attached Lease Agreement.
  - 2. The name of the lessee is Easterseals New Jersey.
- 3. The public purpose served by the Tenant is enumerated in N.J.S.A. 40A:12-15(b), which specifies the following public purpose: "Any activity for the promotion of the health, safety, morals and general welfare of the community of any nonprofit corporation or association." Specifically, the Easterseals New Jersey will be utilizing the space as an office space to house two (2) workforce development programs that will benefit both senior citizens and persons with disabilities in assisting them with job training and placement and other services aimed towards assisting individuals communities in finding and maintaining employment.
- 4. The number of persons benefitting from the public purpose served by the lessee includes but is not limited to the following: upwards of 130 seniors per year in Hudson County; at least 15 individuals within Hoboken specifically, with plans to increase this number through partnerships with the Marian Towers, the City of Hoboken and the Hoboken Shelter and required community education and outreach as specified in the lease agreement.
  - 5. The term of this Lease shall be for ten (10) years.

- 6. The individual responsible for enforcement of the conditions of the lease within the City of Hoboken is the Director of Community Development.
- 7. The lessee will annually submit a report to the City of Hoboken Director of Community Development ("Annual Report"), and which report shall include the following: the use to which the leasehold was put during each year; the activities of the lessee undertaken in furtherance of the public purpose for which the leasehold was granted; the approximate value or cost, if any, of such activities in furtherance of such purpose; and an affirmation of the continued tax-exempt status of the nonprofit corporation pursuant to both State and federal law.

## THE MAYOR AND COUNCIL OF THE CITY OF HOBOKEN DOES HEREBY ORDAIN AS FOLLOWS:

<u>Section 1:</u> The following <u>additions</u> shall be made to Hoboken City Code Article I § 46-7 to read as follows:

#### § 46-8 through § 46-9. (Reserved) Execution of Lease Agreement with Easterseals New Jersey

The Mayor is hereby authorized to enter into and execute the attached lease agreement (Exhibit A) and same shall become part of the Hoboken Administrative Code for the term of the lease.

<u>Section 2:</u> This Ordinance shall be a part of the Code of the City of Hoboken as though codified and fully set forth therein. The City Clerk shall have this Ordinance codified and incorporated in the official copies of the Code.

<u>Section 3:</u> The City Clerk and the Corporation Counsel are authorized and directed to change any Chapter, Article and/or Section number of the Code of the City of Hoboken in the event that the codification of this Ordinance reveals that there is a conflict between the numbers and the existing Code, and in order to avoid confusion and possible accidental repealers of existing provisions not intended to be repealed.

**Section 4:** This ordinance shall take effect as provided by law.

<u>Section 5:</u> All ordinances or parts thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only however, to the extent of such conflict or inconsistency, it being the legislative intent that all ordinances or part of ordinances now existing or in effect unless the same being conflict or inconsistent with any provision of this Ordinance shall remain in effect. This Ordinance shall also supersede any inconsistent provisions contained in any resolution or ordinance previously adopted by the Hoboken City Council.

<u>Section 6:</u> The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason be held to be invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, but shall remaining in effect; it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

**Section 7:** This Ordinance shall take effect upon passage and publication as provided by law.

AN ORDINANCE TO CREATE ARTICLE VI ENTITLED "TEMPORARY NO PARKING SIGNS" IN CHAPTER 190 ENTITLED "VEHICLES AND TRAFFIC" TO AMEND REGULATIONS REGARDING THE SALE AND USE OF TEMPORARY NO PARKING SIGNS (B-71)

**WHEREAS**, temporary no parking (TNP) signs are used as a means of reserving temporary curbside access in a safe and orderly manner for functions essential to urban life, including moving in or out of Hoboken, clearing streets for construction, emergencies, or street fairs, accommodating high-volume loading activity for special events, staging for home improvement contractors, etc.; and,

**WHEREAS**, the Hoboken Parking Utility has taken many recent steps in an effort to improve awareness of active and upcoming temporary no parking zones, including the launch of an outcall notification system that calls resident parking permit holders parked adjacent to newly posted TNP signs and an online map that shows the real time location of all active and future TNP signs; and,

**WHEREAS**, under current Hoboken Parking Utility policies, temporary no parking signs must be posted a minimum of three (3) days in advance in permit zones and a minimum of 24 hours in advance in meter-only zones; and,

**WHEREAS**, the Hoboken Parking Utility will launch a six month pilot program to require seven (7)-day advanced posting of temporary no parking signs in permit parking zones for certain temporary no parking requests, including residential moving, moving storage containers, dumpsters, block parties, television and film events, street fairs, and other circumstances as deemed necessary by the Director of the Department of Transportation and Parking.

THE MAYOR AND COUNCIL OF THE CITY OF HOBOKEN DOES HEREBY ORDAIN AS FOLLOWS:

<u>Section 1:</u> The following <u>additions</u> shall be made to Hoboken City Code **Chapter 190, Article VI** (which is currently reserved) to read as follows:

#### **PLACEHOLDER**

<u>Section 2:</u> This Ordinance shall be a part of the Code of the City of Hoboken as though codified and fully set forth therein. The City Clerk shall have this Ordinance codified and incorporated in the official copies of the Code.

<u>Section 3:</u> The City Clerk and the Corporation Counsel are authorized and directed to change any Chapter, Article and/or Section number of the Code of the City of Hoboken in the event that the codification of this Ordinance reveals that there is a conflict between the numbers and the existing Code, and in order to avoid confusion and possible accidental repealers of existing provisions not intended to be repealed.

**Section 4:** This ordinance shall take effect as provided by law.

<u>Section 5:</u> All ordinances or parts thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only however, to the extent of such conflict or inconsistency, it being the legislative intent that all ordinances or part of ordinances now existing or in effect unless the same being conflict or inconsistent with any provision of this Ordinance shall remain in effect. This Ordinance shall also supersede any inconsistent provisions contained in any resolution or ordinance previously adopted by the Hoboken City Council.

<u>Section 6:</u> The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason be held to be invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, but shall remaining in effect; it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

AN ORDINANCE AMENDING CHAPTER 68 OF THE HOBOKEN CITY CODE ENTITLED "ALCOHOLIC BEVERAGES" AT §68-7 TO ESTABLISH A PROCEDURE FOR PETITIONING THE CITY COUNCIL FOR AN EXCEPTION TO THE 500 FOOT RULE AND TO REQUIRE NOTICE TO CERTAIN PROPERTY OWNERS (B-72)

**WHEREAS**, pursuant to Hoboken City Code § 68-7G, "any person owning, or under contract or option to purchase, a plenary retail consumption license may petition the City Council for an exception to the rule prohibiting a transfer to be made to other premises within a distance of 500 feet from any other premises then covered by a plenary retail consumption license..."; and,

**WHEREAS**, this legislation is necessary to establish a procedure for the hearing of such requests for an exemption before the City Council; and,

**WHEREAS**, this legislation also requires that notice be sent to certain affected property owners in advance of the hearing before the City Council.

# THE MAYOR AND COUNCIL OF THE CITY OF HOBOKEN DOES HEREBY ORDAIN AS FOLLOWS:

**SECTION ONE:** The following <u>additions</u> and <u>deletions</u> shall be made to Chapter 68 "Alcoholic Beverages" as follows:

## § 68-7. Five-Hundred-Foot Rule.

A. Except as set forth in Subsection F of this section, no plenary retail consumption license without broad package privileges (License Type 33), except renewals for the same licensed premises and transfers of license from person to person within the same premises, shall be granted or transfer made to other premises within a distance of 500 feet from any other premises then covered by a plenary retail

consumption license without broad package privileges (License Type 33). Should a license held by a restaurant be transferred to another location for use as a tavern, the restriction promulgated herein shall apply.

- B. No plenary retail consumption license with broad package privileges (License Type 32), except renewals for the same licensed premises and transfers of license from person to person within the same premises, shall be granted or transfer made to other premises within a distance of 500 feet from any other premises then covered by a plenary retail consumption license with broad package privileges (License Type 32). There shall be no exceptions to this restriction. Should a license held by a restaurant be transferred to another location for use as a tavern, the restriction promulgated herein shall apply.
- C. No plenary retail distribution license, except renewals for the same premises and transfers from person to person, shall be granted or transfer made to other premises within a distance of 500 feet from any other premises then covered by a plenary distribution license.
- D. Where the five-hundred-foot distance is referred to in this section, the same shall be measured by a distance from the center of the entrance door of an existing tavern to the center of the entrance door of a proposed licensed premises as measured by walking along the sidewalk from point to point without any diagonal crossing of streets. If it is necessary to cross a street, such steps are to be taken at the lawful crosswalks in a direct manner. The local license issuing authority may, in its discretion, grant a transfer of an existing license to the same licensee to other premises within 250 feet of the premises from which the transfer is made, notwithstanding that the premises to which the license is so transferred is within 500 feet of an existing plenary retail consumption licensed premises, and grant transfer of such license free of such five-hundred-foot limitation herein fixed in the event of any licensed premises being taken by condemnation for any municipal, county, state or federal project; provided, nevertheless, that the new location to which the license is to be transferred under this exception shall not be located within a distance of 250 feet of a then-existing location licensed to do business under a like license as the one being transferred. Said two-hundred-fifty-foot distance shall be measured in the same manner as herein provided for the measuring of the five-hundred-foot distance. In the event that any transfer of a license should be allowed under this exception, then and in that event no license shall thereafter be transferred to the premises or any part thereof so vacated by such transfer, nor within a radius of 250 feet thereof; provided, however, that all other provisions of this chapter and applicable law relating thereto are complied with.
- E. "Restaurant," as defined in this section, shall mean an establishment regularly and principally used for the purpose of providing meals to the public, having an adequate kitchen and dining room equipped for the preparing, cooking and serving of food for its customers and in which no other business, except such as is incidental to such establishment, is conducted and where such premises shall conform to local and state fire and health codes.

- F. The following are exceptions to the five-hundred-foot rule prohibition set forth in Subsection A above:
- (1) The prohibition shall not apply to the Southern Redevelopment Area as defined in the "Hoboken City Code § 68-7 Five-Hundred-Foot Rule Map." However, in said area, the number of plenary retail consumption licenses shall be limited to seven.
- (2) The prohibition shall not apply to the area identified as the Central Business District as defined in the "Hoboken City Code § 68-7 Five-Hundred-Foot Rule Map." However, in said area, the number of plenary retail consumption licenses shall be limited to 25.
- (3) The prohibition shall not apply to the Neumann Leathers Redevelopment Area as defined in the "Hoboken City Code § 68-7 Five-Hundred-Foot Rule Map." However, in said area, the number of plenary retail consumption licenses shall be limited to three.
- (4) The prohibition shall not apply to the Western Edge Redevelopment Area as defined in the "Hoboken City Code § 68-7 Five-Hundred-Foot Rule Map." However, in said area, the number of plenary retail consumption licenses shall be limited to 10.
- (5) The prohibition shall not apply to the Southwest Redevelopment Area as defined in the "Hoboken City Code § 68-7 Five-Hundred-Foot Rule Map." However, the total number of plenary retail consumption licenses in said area shall be limited to five.
- (6) The prohibition shall not apply to the portion of Hoboken designated as the Third Ward in the "Hoboken City Code § 68-7 Five-Hundred-Foot Rule Map." However, the total number of plenary retail consumption licenses in said area shall be limited to 15.
- (7) The prohibition shall not apply to the portion of Hoboken designated as the First Ward in the "Hoboken City Code § 68-7 Five-Hundred-Foot Rule Map" that is not included in the Central Business District or the Southern Redevelopment Area, as those terms are defined in subsection E(2) and E(1), respectively, above. However, the total number of plenary retail consumption licenses in said area shall be limited to 10.
- (8) The prohibition shall not apply to any plenary retail consumption license designated as a theater exception "37" license in the City of Hoboken.
- G. Any person owning, or under contract or option to purchase, a plenary retail consumption license may petition the City Council for an exception to the rule prohibiting a transfer to be made to other premises within a distance of 500 feet from any other premises then covered by a plenary retail consumption license (as set forth in § 68-7A, above). If the petition is granted, the total number of plenary retail consumption licenses enumerated in Section F shall not change. Such an exception shall

require six votes of the Council and only be granted based on the criteria of extraordinary circumstances. The procedure for review of petitions by the Council shall be as follows:

- 1. The hearing may be held at any regular council meeting or a special council meeting.
- 2. The City Council will act as the trier of fact and sit in a quasi-judicial capacity, and a member of the Council shall be designated as "chair" of the hearing.
- 3. The petitioner will be consulted as to the date and time of the hearing and may be represented by an attorney.
- 4. The petitioner may present testimony or other evidence on his or her behalf.
- 5. The petitioner and all of his or her witnesses shall swear or affirm to testify truthfully before giving any testimony.
- 6. The petitioner will enter his or her appearance and be sworn in by the City Clerk. If the applicant is represented by an attorney, the attorney shall enter his or her appearance and may proceed with an opening statement.
- 7. The petitioner shall provide the City Clerk in advance of the hearing with 12 copies of all documentary evidence or exhibits upon which the petitioner intends to rely or refer to during the hearing. The petitioner or his or her attorney shall then present the testimony of the petitioner's witness(s), which may include the petitioner.
- 8. After each witness concludes his or her testimony for the petitioner, members of the public may then pose questions to the witness related to the testimony provided by the witness. Each member of the public shall be limited to a total of five (5) minutes for questions unless otherwise allowed by the chair of the meeting. This time shall be limited to asking questions; members of the public shall not be permitted to make a statement regarding the petition at this juncture.
- 9. After the members of the public are done asking the witness questions, the City Council may then pose questions to the witness.
- 10. The procedures enumerated in subsections (8) through (9) apply for each of the petitioner's witnesses.
- 11. When all of the petitioner's witnesses have been presented, the Administration shall have the right to present evidence that is relevant to the petition. If the Administration chooses to rely on documentary evidence or exhibits during the hearing, it must provide the petitioner with a copy of the documentary evidence or exhibits in advance of the hearing as well as copies for the public to review at the hearing. The Administration shall also have the right to call witnesses to testify as to the particular facts of the petition. The procedure for each of the petitioner's witnesses, as set forth in subsections (8) through (9), shall be applicable to any Administration witness.

- 12. After all testimony is completed, the chair shall open the hearing for public comment. Members of the public may then issue comments or statements in favor of or opposition to the petition. Each member of the public shall be limited to a total of five (5) minutes to make a statement.
- 13. Once the public comment period has concluded, the petitioner or his or her attorney may then issue a closing statement. The duration of each witness' testimony elicited by petitioner and the closing statement will be determined by the chair, based in large part on the complexity of the petition and testimony.
- 14. The hearing will be closed after all parties who wish to be heard on the petition have been heard. The City Council will then deliberate the matter in public, followed by a motion and vote. The City Council's decision will be described in detail in a resolution, adopted at either the same meeting or next scheduled meeting. The City Council may defer its decision to a subsequent council meeting; however, a decision must be rendered at one of the next two regularly scheduled council meetings. If the City Council defers its decision to a subsequent meeting, the petitioner will be notified of the date and time of said meeting.

H. Notice of a the hearing shall be given at least fifteen (15) days prior to the hearing by the petitioner to the owners of all real property as shown on the current tax duplicates, located within 200 feet in all directions of the proposed location that is the subject of the hearing. In addition, the petitioner shall provide notice of the hearing to all owners of a plenary retail consumption license without broad package privileges (License Type 33) as shown on the current tax duplicates that are located within 500 feet in all directions of the proposed new location that is the subject of the hearing.

The notice shall be by regular mail. The notice shall state the date and time and place of the hearing, the nature of the matter to be considered, and an identification of the proposed location by street names and address, common names or other identifiable landmarks, such as lot and block numbers as shown on the current tax duplicate in the municipal tax assessor's office.

Notice shall be given to a property owner by serving a copy thereof on the property owner as shown on the said current tax duplicate, or his agent in charge of the property, such as the property manager or registered agent, or any other person authorized by law to accept service on behalf of the owner.

The petitioner shall be responsible for all costs of the notice provision.

The petitioner's failure to provide proper notice to any of the above-referenced affected property or license owners shall not, de facto, invalidate the petition, hearing or any action that is taken at the

hearing, such as the approval or denial of the petition, but such a failure may be considered by the council as a ground for denial of the petition. For purposes of this section, placement of the petition on the agenda shall be considered adequate notice for all parties and affected property owners.

- B. Any vehicle parked on a street posted as resident permit parking only, without a valid resident permit, shall be subject to a parking fine, as provided by ordinance, a vehicle boot, and after proper notice, towing of the vehicle to a lot as designated by the Parking Utility.
- C. Any vehicle with an expired permit and parking on a street posted as permit parking only or for resident permit parking only shall be subject to the same penalty as a vehicle parked on the street without a permit.

ORDINANCE AMENDING §110-8 BRUSH, WEEDS AND OBNOXIOUS PLANTS AND § 110-10 ABATEMENT OF ACCUMULATION BY CITY (COUNCIL MEMBER DEFUSCO)

**NOW, THEREFORE**, the City Council of the City of Hoboken does hereby Ordain as follows (additions noted in underline, deletions noted in strikethrough):

#### **SECTION ONE:**

#### § 110-10 Abatement of accumulation by City

Whenever vacant an owner of real property has been cited by the municipality City for violations of this chapter on two or more occasions and the owner of the property has not abated the accumulation issue in the citation, the Department of Environmental Services, by order of the Director of the Department, shall may take any and all measures necessary to abate the issue in the citation further accumulation of refuse by erecting a fence around the property and by such other steps as are deemed necessary. The Director of the Department of Environmental Services shall submit to the City Council a list of all properties abated by this City in accordance with this section within one month of action being taken. The City Council shall affirm the action of the Department of Environmental Services by resolution. Thereafter, the Director shall certify the costs of abatement to the Tax Collector, and such costs shall thereupon become a lien upon the property to the same extent as liens for unpaid municipal property taxes. In addition, the City may have an action to recover such costs against the owner of such lands in any court having jurisdiction thereof.

**WHEREAS**, as of September 17, 2018, Mayor Bhalla has not fulfilled his legal responsibility to negotiate a contract, leaving the hard working members of the Hoboken Fire Department leadership without the job security they deserve; and,

**WHEREAS**, according to §40:69A-36 it is the City Council who may conduct a legislative inquiry; and,

**WHEREAS**, according to §40:69A-40 it is the Council who approves contracts negotiated by the mayor.

**NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL,** that we hereby request an update from Mayor Bhalla by October 3, 2018 as to the status of negotiations with Hoboken Fire Officers Association, Local 1076 and International Association of Fire Fighters AFL-CIO, CLC.

**BE IT FURTHER RESOLVED,** that the City Council would like to see a successful negotiation concluded no later than December 31, 2018, thus permitting the Council to approve a contract at its' first meeting in 2019.

RESOLUTION URGING THE PORT AUTHORITY OF NEW YORK AND NEW JERSEY TO CONSIDER UPGRADES TO PORT AUTHORITY TRANS- HUDSON (PATH) TRAINS AND SERVICE LEVELS

**WHEREAS,** the City Council holds our relationship with Port Authority in high regard and is appreciative of the current positive train control installation underway within the Port Authority Trans-Hudson (PATH) system; and,

**WHEREAS,** the City Council is thankful for the Port Authority's continued commitment to run service overnights and on weekends between Hoboken and Manhattan; and,

**WHEREAS**, PATH has long supported Hoboken's population who are dependant on the service to get to and from Manhattan for both business and recreational pursuits; and,

**WHEREAS**, use of the PATH service has grown exponentially over the last five years, with the system carrying 82.8 million passengers, 283,719 daily in 2017; and,

**WHEREAS**, over the last 5 years, system-wide ridership during the morning (5-10a) and evening (3-7p) rush hours has increased by an average of 16 percent, causing trains to be overcrowded, especially on the Hoboken to 33rd Street line; and,

**WHEREAS**, on weekends, both Hoboken and Jersey City share a line to and from 33rd Street, a service which is regularly overcrowded, despite fewer trains running through the system; and,

**WHEREAS,** the Metropolitan Transportation Authority (MTA) subway installed public Wifi system-wide in Jan 2017 to the benefit of their ridership; and,

**WHEREAS**, PATH does not currently offer its' riders access to public Wifi, often to the detriment of commuters looking to conduct business while on their way to work, or who wish to use the PATH app while underground.

## NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL, THAT WE HEREBY URGE PORT AUTHORITY TRANS-HUDSON (PATH) TO CONSIDER:

- 1. Running additional PATH trains between Hoboken and 33rd Street during weekday rush-hour periods to aid overcrowding.
- 2. Running separate PATH lines between Jersey City and Hoboken during peak periods over the weekends to aid overcrowding.
- 3. Installing public Wifi throughout the PATH system.

**BE IT FURTHER RESOLVED,** that the City Clerk should distribute this resolution to The Port Authority's Executive Director, Chairman and Chief of Public and Government Affairs.
