ENGINE – Gas/Diesel: All internally lubricated parts, camshaft and bearings, connecting rods and bearings, crankshaft and bearings, cylinder block, main bearings, distributor shaft, exhaust manifold, intake manifold, oil pump, gears and pick-up screen, pistons, piston rings and wrist pins, timing chain and gears, timing belt, cylinder heads, exhaust valves, intake valves, valve springs and retainers, push rods, rocker arms and shafts, and hydraulic and solid lifters.

Drive axle housing covered only if damaged by an internally lubricated part.

AIR CONDITIONING (OEM equipment only): Compressor, compressor clutch, compressor coil, accumulator, dryer/ receiver, condenser, and evaporator.

BRAKES: All internally lubricated parts of the hydraulic system including the master cylinder, vacuum power assist booster and valve, hydro booster, disc brake calipers, wheel cylinders, steel brake lines and hoses.

ENGINE COOLING SYSTEM: Radiator, water pump, thermostat, radiator fan and fan clutch.

ELECTRICAL: Alternator, electric horn, front wiper motor, rear wiper motor, rear defroster switch, starter motor, starter solenoid, and voltage regulator.

FUEL SYSTEM: Primary fuel pump, metal fuel lines, and fuel level sending unit.

STEERING: Power steering pump, rack and pinion, and steering gear box.

SEALS & GASKETS:

NORMAL WEAR & TEAR:

Provides coverage for normal wear and tear when it causes the failure of a covered component on vehicles with less than 125,000 miles at the time of purchase.

MANDATORY SURCHARGES:

If you have a vehicle with the below engine type, or titled as, used for, or equipped with the below, a mandatory surcharge will be applied to your coverage.

DIESEL VEHICLES

Provides coverage for by-mechanical-failure-only fuel pump (electric or mechanical), pressure regulator, metering valve and fuel injectors.

4 WHEEL/ALL WHEEL DRIVE

Provides coverage for all internally lubricated parts, transfer case, bearings, bushings, chains, gears, sleeves, and sprockets.

TURBO/SUPERCHARGER (OEM equipment only)

TIRE HEIGHT/LIFT KIT MODIFICATIONS

Provides coverage for vehicles equipped with oversized tires or body or suspension lifts at the time of vehicle purchase. Maximum increase for body/suspension lift combined cannot exceed 6" inches. Maximum tire height modification is 4" inches in overall diameter larger than manufacturer's specifications.

COMMERCIAL USE

LIMIT OF LIABILITY: Our Aggregate Limit of Liability for all pending and paid claims under a Secure Care Contract shall not exceed the lesser of NADA retail value at the time of breakdown as determined by the NADA Used Car Guide (without consideration of or deduction for the cost of repairs associated with the breakdown) or: (1) \$1,500 on all contracts with 3 or 6 month terms; (2) \$6,500 if you select Level 1 coverage for a term of 12 months or greater; or (3) \$8,500 if you select Level 2 coverage for a term of 12 months or greater.
