JOB DESCRIPTION – Janitor

Classification – Non-Exempt

Direct Report - General Manager

SUMMARY/OBJECTIVE

A Janitor is responsible for cleaning tasks as assigned on restaurant property. They must comply with all applicable sanitation, health, and personal hygiene standards. The Janitor is responsible for appropriate use of facility supplies and equipment to minimize loss, waste, and fraud.

ESSENTIAL FUNCTIONS

Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

- Responsible for various assigned cleaning duties in the restaurant and on restaurant property.
- Complies with established sanitation standards, personal hygiene, and health standards.
- Washes and properly stores ceramic, glass, metal, and plastic serving dishes and glasses.
- Report to work in a neat a clean uniform. Personal hygiene is essential.
- Reports necessary equipment repair and maintenance to supervisor.
- Always keeps work area neat and clean.

WORK ENVIRONMENT

This job operates in a fast-paced restaurant setting. The noise level in the work environment can be loud. The employee may be exposed to hazards including, but are not limited to, cuts, slipping, tripping, falls, and burns.

May work with hazardous equipment including oven, stove, dishwasher, slicer, fryers, grill, salamander, griddle, floor buffing machine, and power washer. The employee is frequently exposed to heat, steam, hot oil, fire, and noise. Frequent hand washing is required.

PHYSICAL DEMANDS

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job.

- The employee is required to stand, walk, reach, climb ladders, lift, bend, kneel, stoop, and twist for 8 to 14 hours a day.
- The employee is required to push, pull, or lift items weighing 50 pounds or less. May be required to push or pull items exceeding 100 pounds (with assistance).
- The position requires manual dexterity; auditory and visual skills; and the ability to follow written and oral instructions and procedures.

POSITION TYPE/ EXPECTED HOURS OF WORK

This is a variable position. Days and hours of work are dependent upon employee availability, staffing needs, and competence of the job. Scheduled meetings are considered mandatory without explicit approval. Shifts will often begin and end outside of general hours of operation and can fall between the hours of 7 a.m. and 5 a.m. Hours of operation vary by location and are subject to change.

PREFERRED EDUCATION AND EXPERIENCE

- Prior experience in a related food service position.

ADDITIONAL ELIGIBILITY QUALIFICATIONS

- A Texas food handler certification is required upon employment and must be maintained for the duration. Some locations require registration within a county or city.
- All employees in this position must pass required exams position.
- All employees are required to complete continued education training as necessary.

WORK AUTHORIZATION/SECURITY CLEARANCE

- All employees must be authorized to work in the United States and are expected to provide original documentation at Orientation and at HR's request thereafter.
