WHAT IS THE STUDY ABOUT AND WHY IS IT IMPORTANT?

This study is being conducted on behalf of Reconciliation Victoria (RV) through our research team and Blue Horizon Research. We are seeking feedback from Victorian residents on a range of issues affecting Indigenous Australians, and non-Indigenous Australians, with a focus on Victorian culture and knowledge, and RV's work in Reconciliation. The data gathered will help inform RV of the current level of understanding and engagement of issues of Reconciliation in Victoria today, with a view to improving their services in the future.

WHAT DOES THE STUDY INVOLVE AND WHAT IS THE TIME COMMITMENT?

You will be asked to participate in a short online survey to gain your perspectives on your current knowledge, and what you'd like to hear about in the future in the reconciliation space. The survey should take you approximately 10 minutes to complete.

Participation in this study is voluntary and you are free to withdraw or stop the survey at any time. You are also welcome to not answer any questions you do not wish to answer. See below for further information on withdrawing from the study.

WILL ALL DATA PROVIDED BE CONFIDENTIAL?

You have received this survey as you are a registered panel member of Pure Profile online survey community. Your Pure Profile unique identifier is only used to help you earn rewards You will only be required to provide some brief personal information (e.g. age, gender, cultural background, employment status and postcode) during the survey for comparative purposes, and will not make you identifiable. All data collected by the research team is de-identified, so you cannot be identified. All processed data will be stored electronically with password protection.

HOW WILL THE DATA BE USED?

The results will be used to help inform Reconciliation Victoria of the current level of knowledge and understanding of reconciliation issues for Victorians, and where future services may be required. The data will not be used in any other way, or for any other purpose and will be stored electronically with password protection for the duration of the project.

ARE THERE ANY RISKS IF I PARTICIPATE?

We do not anticipate that you will be at any risk while you are participating. However, if you feel uncomfortable answering any questions at any time, you are free to not answer any particular questions or withdraw from the survey.
