

SECTICS/MS ORDINANCE #60, of August 5, 2025

THE SECRETARY OF SCIENCE, TECHNOLOGY, AND INNOVATION AND OF THE HEALTH ECONOMIC-INDUSTRIAL COMPLEX OF THE MINISTRY OF HEALTH, in the use of the powers conferred upon her by Article 68, Annex I of the Decree #11,798 of November 28, 2023, hereby decrees:

Article 1. The Technical Advisory Committee to support the Productive Development Partnerships Program (CTCPDP) is hereby established.

Paragraph 1. The CTCPDP shall be responsible for:

- I - Advising the Secretariat of Science, Technology, and Innovation and of the Health Economic-Industrial Complex (SECTICS) on the monitoring and evaluation of Productive Development Partnerships (PDP);
- II - Providing technical support to SECTICS in technology-scouting activities;
- III - Preparing opinions and recommendations for enhancement of the Program;
- IV - Assisting SECTICS in formulating strategies for PDPs.

Paragraph 2. All outputs, opinions, recommendations or other communications issued by the CTCPDP shall be strictly advisory in nature and shall not be binding on SECTICS.

Article 2. The Technical Advisory Committee to support the Productive Development Partnerships Program shall consist of:

- I - The Director of the Department of the Health Economic-Industrial Complex and Innovation (DECEIIS);
- II - The Director of the Department of Science and Technology (DECIT);
- III - The Director of the Department of Management and Incorporation of Health Technologies (DGITS);
- IV - Specialists from the scientific community with recognized technical competence and distinguished professional expertise in pharmaceuticals, vaccines, blood derivatives, and medical devices.

Sole Paragraph. Members of the CTCPDP may not designate representatives or alternates in the event of their unavailability to attend meetings.

Article 3. Specialists shall be appointed by a specific Ordinance issued by the Secretary of Science, Technology, and Innovation and of the Health Economic-Industrial Complex.

Article 4. The CTCPDP shall be coordinated by the Director of the Department of the Health Economic-Industrial Complex and Innovation (DECEIIS), with the following responsibilities:

- I - Coordinate the CTCPDP meetings;
- II - Designate a representative of DECEIIS to facilitate the CTCPDP deliberations and operations;
- III - Provide relevant information and data to CTCPDP meetings.

Article 5. CTCPDP meetings shall be held in Brasília, Federal District.

Article 6. Participation in the CTCPDP shall be deemed performance of a significant public service and shall be uncompensated.

Article 7. This Ordinance takes effect upon its publication date.
