MISCELLANEOUS MUNICIPAL SERVICE RIDER RATE SCHEDULE (Name of Schedule)

AVAILABLE: In the retail distribution service territory of the District.

APPLICABLE: To cities and villages for miscellaneous municipal services (excluding municipal pumping), school districts, counties, and other state and local (non-federal) government agencies that are principally funded (>50%) by local and state (non-federal) taxes and are served under the following rate schedules*:

General Service (Rate Codes 56 & 63)

General Service Demand (Rate Codes 23, 24, 66 & 67)

* This Rate Schedule does not apply to accounts taking service under the Standby Service Rider Rate Schedule (ST-Rider) or to accounts that would qualify for the Municipal Pumping Service Rate Schedule (M-4) but instead the Customer has elected to take service under the High Tension Service Rate Schedule (HTS), General Service Rate Schedule (GS), or General Service Demand Rate Schedule (GSDM).

Examples of entities that may qualify for this Rate Schedule if principally funded (>50%) by local and state (non-federal) taxes include, but would not be limited to, the following: public schools, county courthouses, city halls, city or village police and fire protection facilities, county maintenance shops, community college facilities, Nebraska State College and University facilities, State of Nebraska agency and department facilities (e.g., Nebraska State Patrol, Department of Roads, Department of Labor).

The District ultimately reserves the right to determine applicability.

BASE RATE: The base rates and charges for electric service regularly applicable under the rate schedules listed above.

DISCOUNT: A thirty-three and one-third percent (33 1/3%) discount shall apply to the billing as computed under the applicable rate schedule, excluding PCA and applicable Base Rate Adjustment, but including applicable primary service discount and power factor adjustment, except that:

TAX CLAUSE: In the event of the imposition of any new or increased tax or any payment in lieu thereof, in excess of that provided for under Article VIII, Section 11 of the Nebraska Constitution, by any lawful authority on the production, transmission, or sale of electricity, the rate provided herein may be increased to reflect the amount of such tax or in lieu of tax increase.

MISCELLANEOUS MUNICIPAL SERVICE RIDER RATE SCHEDULE (Name of Schedule)

(1) The net billing (before PCA and applicable Base Rate Adjustment) for any billing period shall not be less than an amount shown in the table below:

Summer (Jun-Sep): 7.9¢/kWh	Winter (Oct-May): 6.5¢/kWh
----------------------------	----------------------------

In no event shall the minimum identified in the table be more than the effective rate yield of the original applicable rate schedule before application of the MM-Rider discount, and

(2) In no event shall this discount apply to the standard rate minimum from the applicable rate schedule, and
(3) This discounted billing is subject to applicable Base Rate Adjustment.

BASE RATE ADJUSTMENT:

Customers that are served from distribution facilities for which the District has a Lease Payment (LP)* or Debt Service (DS) obligation and/or a 5% Gross Revenue Tax (GRT) obligation will have the Base Rate (excluding PCA but including applicable primary service discount, power factor adjustment, and MM-Rider discount) adjusted to include such obligations as shown in the following table:

<u>Applicable Adjustment</u>	<u>Rate Formula</u>
None	Base Rates
Gross Revenue Tax (GRT) Only	Base Rates ÷ 0.95
Lease Payment (LP)* or Debt Service (DS) Only	Base Rates ÷ (1 - applicable Lease Payment or Debt Service obligation percentage)
LP*/DS and GRT	Base Rates ÷ (1 - (5% + applicable Lease Payment or Debt Service obligation percentage))

TAX CLAUSE: In the event of the imposition of any new or increased tax or any payment in lieu thereof, in excess of that provided for under Article VIII, Section 11 of the Nebraska Constitution, by any lawful authority on the production, transmission, or sale of electricity, the rate provided herein may be increased to reflect the amount of such tax or in lieu of tax increase.

MISCELLANEOUS MUNICIPAL SERVICE RIDER RATE SCHEDULE (Name of Schedule)

* Only applicable for Customers in cities and villages where the District has a contractual obligation to pay a Lease Payment to the city or village based on the revenue collected from tax-supported entities taking service and receiving a discount under this Rate Schedule.

In addition, for Customers served from distribution facilities for which the District has a 5% GRT obligation, the PCA will be adjusted to include such obligation by the following formula: $PCA \div 0.95$.

TERMS AND CONDITIONS:

1. Service will be furnished under the District's Retail Service Rules and Regulations.
2. Extensions made for service under this Rate Schedule are subject to the provisions of the District's "General Extension Policy for Retail Electric Services and Facilities".
3. The District's General Customer Service Charges Rate Schedule shall apply.
4. Usage shall be prorated for application of a change in rate or changing from summer to winter or from winter to summer rates. Such proration shall be accomplished by utilizing either the Customer's actual usage in each time period, or by fractionalizing the Customer's total usage according to the number of days of service corresponding to each time period by using the District's billing system.
5. For billing purposes, energy usage shall be normalized to 30 days when actual days of service is less than 27 days or exceeds 35 days in any given billing period.
6. The District retains and reserves the right, power and authority to modify, revise, amend, replace, repeal or cancel this Rate Schedule, at any time and in whole or in part, by resolution adopted by the District's Board of Directors.

TAX CLAUSE: In the event of the imposition of any new or increased tax or any payment in lieu thereof, in excess of that provided for under Article VIII, Section 11 of the Nebraska Constitution, by any lawful authority on the production, transmission, or sale of electricity, the rate provided herein may be increased to reflect the amount of such tax or in lieu of tax increase.
