

Military Vehicle Preservation Association (MVPA) Public Board of Directors Meeting Minutes: Wednesday, July 31, 2025, 8:00pm EDST

Type: Public Board Meeting. 74 MVPA members present. Patrick Tipton called the meeting to order at. 8:01pm ESDT.
