

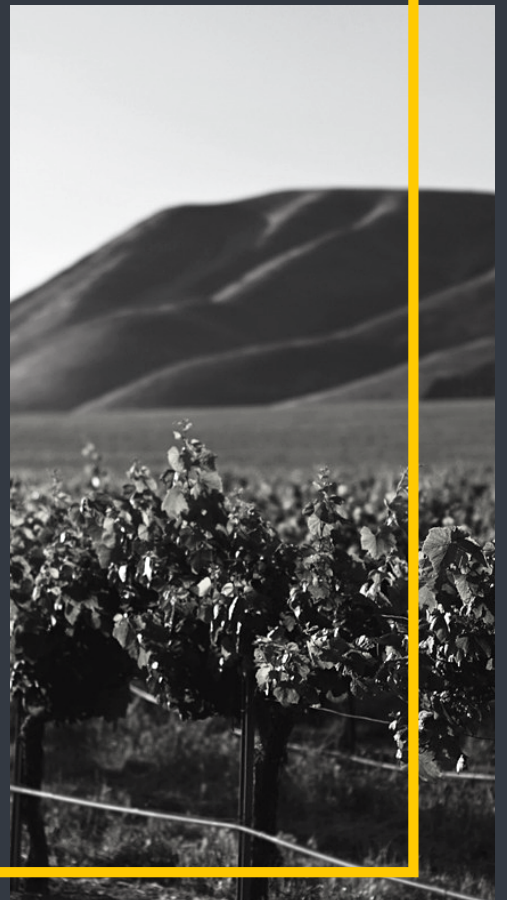
CALIFORNIA WILDFIRE DAMAGE

BEFORE YOU BEGIN

HOME INVENTORY TIPS

Taking the time to record your personal property in this home inventory will save you time, money and frustration when submitting an insurance claim. Gather any receipts, photos, records and serial numbers to prove the value of items lost.

01

LIST EVERYTHING

When creating a home inventory, you need to account for everything of value in your house. List everything, no matter how small.

02

RECORD SERIAL NUMBERS

Many household objects can be identified using a serial number. If possible, record all serial numbers that are available.

03

GATHER RECEIPTS

Though paper receipts may be lost, you may be able to find receipts online. Check bank statements, online order histories and email receipts.

04

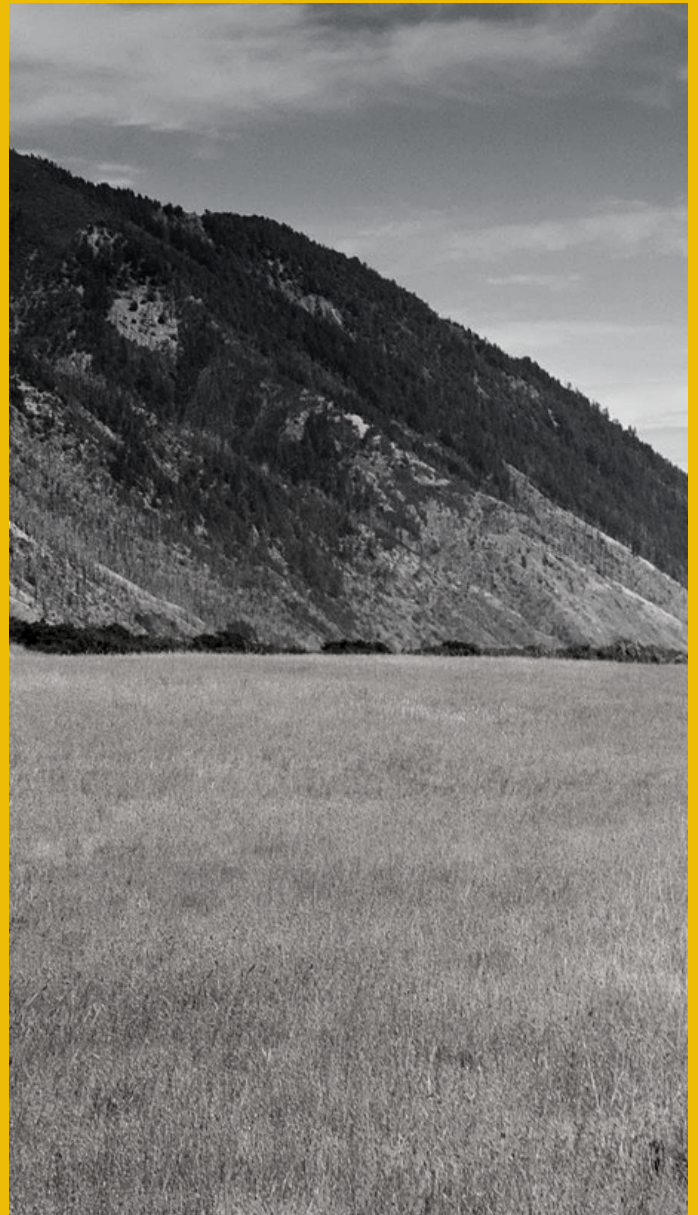
VALUATION RECORDS
