BACKGROUND

Salem Regional Medical Center (SRMC) is an 87 bed, acute-care medical center located in Columbiana County, Ohio. Like other non-profit hospitals, SRMC is required by the Patient Protection and Affordable Care Act (PPACA) to conduct a community health needs assessment (CHNA) and create an Implementation Plan every three years that is easily accessible to the public.

SRMC collaborated with community health care providers to conduct the 2025-2028 CHNA. This multisector, county-wide partnership was designed to promote shared ownership of community health improvement activities; including assessment, planning, implementation and evaluation. SRMC provided financial support and consultative assistance throughout the development of the 2025-2028 CHNA. The CHNA was designed to:

- Provide a description of the community that is consistent with the Hospital's Service Area.
- Identify factors that affect population health.
- Determine the availability of existing resources that can be mobilized to improve community health status.
- Evaluate the Impact of actions taken by SRMC and other community partners to jointly improve population health since the preceding 2022-2025 CHNA was completed.
- Facilitate the development of evidence-based, population-wide interventions and measurable outcomes.

The CHNA was conducted between the Summer of 2024 and June 2025, in a joint process led by the Columbiana County Health Partners' Workgroup (CHNA Workgroup), which included:

IRS Requirements for Implementation Plan & Purpose

In addition to collaborating with other organizations to conduct the required 2025-2028 CHNA, SRMC must fulfill the IRS requirement to adopt a written Implementation Plan with respect to its own hospital facility. This plan satisfies the requirements set forth in Internal Revenue Code Section 501(r)(3), to show how SRMC is addressing the priority health needs identified in the CHNA.

The overall purpose of the implementation strategy process is to align the Medical Center's limited resources, programs, services and activities with the findings of the 2025-2028 CHNA; and define the anticipated impact of each strategy for evaluating progress.

In summary, the CHNA and the Implementation are separate but interconnected requirements.

CHNA requirements include:

- Defining the community served by SRMC.
- Describing the quantitative and qualitative methodology used to identify and prioritize community needs.
- Listing existing community health or health-related resources.
- Prioritizing the list of community health needs to be included in the Implementation Plan.

Implementation Plan requirements include:

- Identifying which community needs the Hospital will address and how.
- Identifying which community needs the Hospital will not address and why.

The Community Health Improvement Plan (CHIP)'s Role in the Implementation Plan

Following approval of the 2025-2028 CHNA by the SRMC Board of Directors on June 19, 2025, SRMC launched its implementation planning process. This process was informed by the CHNA Workgroup via the joint initiation to develop a Community Health Improvement Plan (CHIP), which began in August 2025 and is tentatively scheduled for completion by the end of calendar 2025.

The CHIP is a requirement of the Public Health Accreditation Board for the accreditation of public health departments as a condition for state or local funding and/or to comply with federal mandates. It requires participation from hospitals and/or regional health systems and is designed to set priorities, guide resource allocation and develop and implement measurable projects, programs, and policies. The CHIP is developed with input from a broad range of community stakeholders. As a key member of the CHNA Workgroup, SRMC has actively participated in the CHIP development process.


Selected priorities, strategies, and indicators from the Columbiana County 2025–2028 CHIP were incorporated into SRMC's Implementation Plan and presented to the SRMC Board of Directors for approval in November 2025.

(Note: SRMC's 2025-2028 Implementation Plan was created in collaboration with the preliminary development of the 2025-2028 CHIP, so that the county's population health improvement activities and resources could be coordinated to address identified community needs. However, due to the IRS requirement that SRMC's Implementation Plan be adopted within five months after the end of the taxable year of its CHNA adoption, only about half of the CHIP had been completed by the CHIP Workgroup within that timeframe and available for integration within SRMC's Implementation Planning process.)



2025-2028 SRMC'S IMPLEMENTATION STRATEGY PROCESS

Data from the most recent CHNA was organized into community priorities using the National Association of County and City Health Officials' (NACCHO) framework: Mobilizing for Action through Planning and Partnerships (MAPP 2.0). MAPP 2.0 is a community-driven strategic planning process designed to improve public health by helping communities prioritize health issues and identify resources to address them. The process unfolds in three phases as shown below:



During Phase 2 of MAPP 2.0, the CHNA Workgroup completed three required assessments to identify and prioritize strategic health issues and vulnerable populations. These findings formed the foundation for Columbiana County's 2025–2028 Community Health Improvement Plan (CHIP).

The prioritization results were categorized to ensure the CHIP serves as a catalyst for developing community partnerships and implementing evidence-based interventions. These interventions are designed to address priority health needs identified at the county and state levels. To further align with these top local, state, and national health priorities; SRMC has integrated many of the CHIP's findings into its 2025–2028 Implementation Plan.

SRMC's Implementation Plan outlines the strategies and program activities the hospital intends to deliver, fund or support through collaboration with other organizations. These efforts aim to address the county's

significant health needs over the next three years, including identifying necessary resources and anticipated impacts.

Planned activities are aligned with SRMC's mission, capabilities and the current health needs identified in the CHNA. The Hospital may revise the Implementation Plan as needed to reflect changes in community needs or available resources.

Significant Health Needs & Action Plans

Salem Regional Medical Center (SRMC) is committed to improving community health and delivering meaningful community benefit through the engagement of its staff, clinicians and Board of Directors; in collaboration with community partners. Input for the development of this Implementation Strategy was gathered from SRMC leadership, the CHNA Workgroup and the CHIP Workgroup.

Programs and initiatives selected for the 2025–2028 Implementation Plan were based on:

- Demonstrated success or impact in addressing community needs
- Strategies that reduce health disparities and promote health equity
- Efforts to increase access to care and services
- Expansion of proven programs

Note: Ohio's State Health Improvement Plan (SHIP) encourages hospitals and health departments to address at least one priority factor (e.g., community conditions, health behaviors, access to care) and one priority health outcome (e.g., mental health & addiction, chronic disease, maternal and infant health). SHIP promotes evidence-informed population health policies and programs designed to improve outcomes statewide. SRMC's strategies that align with Ohio's most recent 2020–2022 SHIP are indicated by the symbol.

This Implementation Plan focuses on four priority areas identified in the 2025-2028 CHNA:

- 1. Obesity and Related Lifestyle Factors
- 2. Mental and Behavioral Health
- 3. Chronic Disease Prevention and Management
- 4. Access to Care (Cross-cutting factor)

Each Priority Section Includes:

- Goal Desired long-term impact
- Strategies Core approaches and activities
- Key Partners Organizations and community groups involved
- Outcomes/Indicators Measures of progress and success
- Resources/Timeframe Scope and timeline for implementation

For each high-priority need identified in the CHNA, SRMC reviewed its current programs, outreach efforts, and collaborations and considered new initiatives. Each need was categorized as follows:

- Needs addressed through existing programs and activities: SRMC is already actively providing services to meet the need.
- Needs for which SRMC will enhance existing programs or establish new ones: SRMC may modify
 or expand current activities, or develop new initiatives to address the need.
- Needs SRMC will not address: These are beyond SRMC's capacity to impact effectively.

1. Behavioral Health and Community Need

Behavioral health encompasses mental health conditions, behavioral disorders and substance abuse. These issues often contribute to or worsen physical health problems. Substance abuse includes the use of illicit drugs, misuse of legal medications, and abuse of alcohol and tobacco.

Behavioral health challenges in Columbiana County are closely tied to socioeconomic factors. According to the 2025–2028 CHNA:

- Youth and adults report increased rates of depression and suicide attempts.
- Frequent mental distress has risen over the past three years.
- Suicide rates have increased, as documented by the County Coroner's Report.
- The county faces a shortage of mental health professionals, with a ratio of 770 residents per provider (compared to Ohio's average of 290:1).
- Inpatient treatment options remain limited.

2. Obesity and Community Need

Obesity rates in Columbiana County have significantly increased over the past decade. Measured by the percentage of adults with a body mass index (BMI) of ≥30 kg/m², the county's obesity rate rose from 32.0% in 2016 to 36% in 2021, and reached 45% in 2024. Additionally, 29% of adults report no leisure-time physical activity, compared to 26.7% nationally, contributing to the rising obesity trend.

Findings from the 2025–2028 CHNA indicate that over half of survey participants have had some level of primary care provider involvement related to weight control, physical activity, and/or nutrition. Food insecurity also remains a concern: the county's current rate is 12.9%, exceeding the national average of 11.5%. In 2021, 7.82% of residents reported skipping or cutting meals due to food scarcity, which has nearly doubled to 14.16% in 2024.

3. Chronic Disease & Community Need

Chronic diseases are long-term conditions that typically last one year or more and require ongoing medical attention or limit daily activities—or both. They are among the leading causes of death, disability and rising healthcare costs in the United States.

In Columbiana County, significant chronic health concerns include cardiovascular disease (heart disease, stroke, high blood pressure and high cholesterol), cancer, arthritis, asthma, and diabetes. According to secondary data from the 2025–2028 CHNA, more than half of all deaths in the county are attributable to chronic diseases.

The Robert Wood Johnson Foundation's (RWJF) County Health Rankings highlight a notable disparity in Years of Potential Life Lost before age 75 per 100,000 population:

• Columbiana County (2024): 10,300 years

Ohio average: 9,400 yearsU.S. average: 8,000 years

Additionally, preventable hospital admissions among Medicare beneficiaries in Columbiana County stand at 3,226 per 100,000—significantly higher than the national rate of 2,777 per 100,000.

4. Access to Care: Cross-Cutting Factor

Whether through a doctor's or dentist's office, clinic, hospital, or other appropriate provider; access to care is a critical component of a community's healthcare ecosystem. Columbiana County, designated as part of the Appalachian region, faces persistent disparities in healthcare access. Some of these include high population-to-provider ratios for primary care physicians, dentists and mental health professionals.

The 2025–2028 CHNA consistently identified significant barriers to care, many of which are exacerbated by environmental and socioeconomic factors common in rural Appalachian counties. A lack of health insurance also remains a major obstacle. Uninsured individuals are less likely to have a primary care provider and are less likely to receive preventive, dental, chronic disease or behavioral health services. They are also more likely to be diagnosed at later, less treatable stages of illness, leading to poorer health outcomes, reduced quality of life and higher mortality rates.

Barriers to accessing and utilizing health services contribute to:

- Unmet health needs
- Delays in receiving appropriate care
- · Limited access to preventive services
- Financial strain
- Preventable hospitalizations

In addition to insurance status, other cross-cutting drivers of health disparities include:

- Transportation challenges
- · Poverty and low income
- Cultural beliefs and stigma
- Limited health education and awareness
- · Health equity and health literacy gaps

ADDRESSING SOCIAL DETERMINANTS OF HEALTH & HEALTH DISPARITIES

SRMC's 2025–2028 Implementation Plan incorporates strategies that address many of Ohio's top health priorities and aligns with the goals outlined in Columbiana County's Health Improvement Plan. However, clinical health issues are often rooted in systemic social inequities that lead to poor health outcomes. These underlying factors, which are known as Social Determinants of Health (SDOH), include both individual and community-level challenges.

SDOH are non-medical factors that influence health outcomes and are frequently identified as root causes of health disparities, which are defined by the National Institutes of Health as the differences in the incidence, prevalence, mortality and burden of disease and other adverse health conditions that exist among specific population groups in the United States.

According to the CMS Framework for Health Equity, there are five key domains:

- Economic Stability
- Education Access and Quality
- Health Care Access and Quality
- Neighborhood and Built Environment
- Social and Community Context

Income, employment and economic self-sufficiency are critical social determinants that correlate with a wide range of health problems. Individuals with lower incomes or those who are unemployed or underemployed are less likely to have health insurance and may struggle to afford out-of-pocket healthcare and housing expenses. These economic challenges are also associated with:

- Difficulty securing reliable transportation to medical appointments
- Limited ability to purchase healthy, fresh food consistently
- Increased vulnerability to chronic and preventable health conditions

SRMC's priority populations for reducing health disparities include, but are not limited to:

- Minority racial and ethnic groups
- Individuals living with disabilities
- Residents near or below the poverty level
- Populations affected by social drivers, such as language barriers, housing or food insecurity, and transportation challenges
- Other underserved or marginalized groups identified through local and national resources

Beyond the requirements of the State Health Improvement Plan, SRMC has prioritized health equity, SDOH/HRSN and cultural competency in its 2025–2028 Strategic Planning update and annual Organizational Goals. The Chief Medical Officer, designated by the Governing Body, leads initiatives to reduce healthcare disparities among SRMC inpatients and select outpatient populations.

SRMC's "I CARE" Values Statement serves as the guiding framework for these efforts:

- I Integrity: Do the right thing, even when no one is watching
- **C Compassion**: Be empathetic to the needs of others
- A Accountability: Act responsibly and be excellent stewards of our resources
- R Respect: Value others and honor their dignity, diversity, and privacy
- E Excellence: Strive for personal and professional best

EVALUATION & MONITORING


Progress toward the priorities outlined in SRMC's 2025–2028 Implementation Plan will be tracked using measurable indicators, evaluated at least annually by SRMC's Senior Leadership Team. An annual status update will be presented to the SRMC Board of Directors, and results will be summarized in SRMC's annual IRS Form 990, Schedule H filing.

SRMC will also collaborate on the implementation of the 2025–2028 Columbiana County Community Health Improvement Plan (CHIP) to ensure coordinated and integrated population health initiatives across the County. As a key member of the CHIP Steering Committee, SRMC will participate in semi-annual meetings during the first year of implementation. Depending on progress, meetings may shift to an annual cadence in subsequent years.

The Steering Committee will review action steps, responsible parties and timelines at the end of each year; making revisions to the CHIP as needed. In addition to outcome evaluation, process evaluation will be conducted continuously to assess the effectiveness of implementation efforts.

The Columbiana County Health Partners will continue to facilitate a county-wide Community Health Needs Assessment every three years. Primary data will be collected using nationally standardized survey instruments to enable comparisons at the local, state and national levels. This data will inform measurable outcomes for each priority area.

COMMUNITY NEEDS NOT ADDRESSED BY THE SRMC IMPLEMENTATION PLAN



While SRMC is committed to improving community health, no single healthcare organization can address every need within its service area. SRMC remains focused on its mission, core competencies and strategic use of limited resources to deliver high-impact services and community benefits which yield the greatest opportunities to affect a positive change.

To maximize its effectiveness, SRMC will concentrate its efforts on the prioritized health needs identified earlier in this Implementation Plan. Other community needs, while important, fall outside the scope of SRMC's current capacity due to their societal magnitude.

For example, the top environmental needs identified in the 2025–2028 CHNA's community survey that are beyond SRMC's capacity or scope of focus to independently impact change include:

- Poverty
- Lack of health insurance
- Substandard housing conditions
- Homelessness

- Limited access to employment and better jobs
- Unsafe water and poor air quality
- Drug abuse
- Personal safety concerns

Focus group participants also cited:

- Weather related challenges

- Chemical waste exposure

These observations are supported by the 2025 County data from the Robert Wood Johnson Foundation (RWJF) shown below, reinforcing the need for multi-sector collaboration to address significant environmental determinants of health.

The following health concerns were also identified in the CHNA but are not included in SRMC's 2025–2028 Implementation Plan due to limitations in SRMC's clinical capacity, scope of services or the presence of other community-based providers:

- Dental Health: SRMC does not currently have the clinical resources to provide dental care.
- Drug and Alcohol Abuse: While SRMC offers immediate care in urgent and primary care settings, specialized assessment and treatment programs are provided by other community-based organizations.
- Reproductive Health: SRMC does not offer obstetric services or a maternity unit, and reproductive health care is limited to office-based services provided by primary care providers.
- Smoking and Tobacco Use: SRMC does not currently have the resources to provide smoking cessation education. Vaping is a growing concern and is being addressed through local school health initiatives supported by SRMC.

Despite these exclusions, SRMC recognizes that Columbiana County residents exceed state and national benchmarks in several health indicators. As one of several healthcare resources in the region, SRMC's leadership has adopted a multi-faceted strategy to improve population health:

- 1. Maintain current programs and services while evaluating their effectiveness.
- 2. Explore new programs and services based on best practices proven to address clinical health issues.

3. Partner with external organizations to implement evidence-based strategies that efficiently address regional health concerns.

FORCES OF CHANGE

The 2025–2028 CHNA identified several "forces of change"—external trends, events and factors that are currently impacting or are expected to impact the health of Columbiana County residents. These forces were considered in the development of both the County's CHIP and SRMC's Implementation Plan:

- Staff shortages at healthcare facilities, including local health districts and the Ohio Department of Health (ODH), resulting in limited capacity to deliver healthcare and public health services.
- Medical equipment supply-chain issues, affecting timely access to necessary resources.
- Post-COVID challenges, including increased public mistrust of healthcare workers, misinformation and resistance to vaccines—leading to safety risks and potential disease resurgence.
- Changing patient expectations, with reduced loyalty to individual providers and increased demand for convenient, "drive-through" healthcare services.
- Rising mental health needs, including acute mental illness, substance use and suicide—placing strain on limited behavioral health resources.
- A proven, long-standing collaborative infrastructure, built over years of partnership among health providers and community organizations, serving as a foundation to address these evolving challenges.

GAP ANALYSIS

As part of the CHIP planning process, the CHIP Workgroup will conduct a formal gap analysis to identify discrepancies between community health needs and the availability of viable resources to address those needs. This process will also assess strengths, weaknesses, evaluation strategies and guide strategic action planning.

The gap analysis is scheduled to occur after the selection of strategies and indicators for the CHIP. At the time of SRMC's Implementation Plan's Board approval in November 2025, the gap analysis had not yet been initiated. Once completed, its findings may be included as an appendix to this Implementation Plan.

PUBLIC AVAILABILTY OF THE IMPLEMENTATION PLAN

SRMC's 2025–2028 Implementation Plan will be publicly accessible via the "About Us" section of the SRMC website. It will be linked to the publicly available 2025–2028 CHNA posted in the same location of the website. Hard copies will be available upon request, with printing costs covered by the requestor.

RESOURCES TO ADDRESS NEEDS

SRMC Resources

SRMC's Implementation Plan positions the hospital as both a leader and partner in coordinating county-wide collaboration. SRMC will work with stakeholders to:

- Analyze healthcare utilization
- Explore barriers to access
- · Identify partner needs and resources

- Plan and redesign services
- Measure outcomes against evidence-based benchmarks
- Share accountability for community health improvement

As a recognized leader in population health, SRMC annually allocates budgeted funds and administrative staff hours through its Community Benefit initiatives. These resources support the implementation of activities outlined in this plan and are combined with contributions from local nonprofit organizations to improve health and health equity—especially for low-income, underserved and vulnerable populations.

Overview of County Resources

The CHNA Workgroup identified a wide range of existing healthcare facilities and community resources within Columbiana County and the surrounding region. These resources are available to help address the county's significant health needs and include:
