1. The Giveaway

2. How to enter

- 2.1 The Giveaway is being run by Taptap Send UK from 00:01 on December 15th 2025 (the "**Opening Date**") to 23:59 on December 26th 2025 (the "**Closing Date**") inclusive.
- 2.2 To enter the Giveaway, you may either:

- (1) Use Taptap Send to make a transfer from one of the countries below to Ghana before the Closing Date:
 - (a) Zone UK: the United Kingdom
 - (b) Zone EU: Ireland, Netherlands, Austria, Belgium, France, Germany
 - (c) Zone US: United States, except for Nebraska, North Dakota, Vermont

or,

- (2) Enter for free by submitting your details via the [Giveaway Form](#) during the Qualifying Period.

No purchase is necessary to enter the Giveaway. A purchase will not improve your chances of winning a prize in the Giveaway.
