IN RESPONSE TO THE NEEDS OF LOCAL ARTISTS FOLLOWING HURRICANE HELENE, THE CENTER AWARDED AN ADDITIONAL \$903,000 IN GRANTS TO 849 ARTISTS THROUGH THE CRAFT FUTURES FUND.

LAUNCHED IN 2024, THE NEW ALUMNI NETWORK PROGRAM - AN INITIATIVE TO DEEPEN AND STRENGTHEN OUR WORK WITH ARTISTS AND OUR ABILITY TO SUPPORT AND CONNECT THEM - NOW HAS OVER 260 ACTIVE MEMBERS. IN JUNE 2025, THE CENTER AWARDED 10 ALUMNI UNRESTRICTED MICRO-GRANTS TO SUPPORT TRAVEL AND MATERIAL PURCHASES, AS A CONTINUATION OF THE CENTER'S INVESTMENT IN OUR ALUMNI'S WORK BEYOND THEIR INITIAL AWARDS. FURTHERMORE, WE HAVE SOUGHT WAYS TO AMPLIFY OUR ALUMNI IN OUR EXHIBITIONS AND PROGRAMS, CREATING A MORE INTEGRATED AND ONGOING SUPPORT SYSTEM FOR OUR AWARDEES BEYOND THEIR INITIAL FUNDING.

THE CENTER SUPPORTS INNOVATIVE RESEARCH AND CRAFT SCHOLARSHIP THROUGH THE CRAFT RESEARCH FUND AND CRAFT ARCHIVE FELLOWSHIP. A VISIONARY PROGRAM DEDICATED TO SUPPORTING SCHOLARLY CRAFT RESEARCH IN THE UNITED STATES, THE CRAFT RESEARCH FUND IS THE CENTER'S LONGEST-RUNNING GRANT PROGRAM. THE CRAFT ARCHIVE FELLOWSHIP, WHICH PROMOTES ARCHIVAL RESEARCH ON UNDERREPRESENTED AND NON-DOMINANT CRAFT HISTORIES IN THE UNITED STATES, RECEIVED 260 APPLICATIONS AND AWARDED 6 GRANTS TOTALING \$30,000 THIS YEAR. THE CENTER FOR CRAFT HAS BECOME A VITAL COMMUNITY RESOURCE IN WESTERN NORTH CAROLINA, SERVING VISITORS ANNUALLY THROUGH TOP-NOTCH PROGRAMS. FREE TO THE PUBLIC, OUR GALLERIES OFFER EXHIBITIONS AND AN ENGAGEMENT STUDIO, WHERE VISITORS CAN EXPLORE CRAFT PUBLICATIONS AND OTHER HANDS-ON ACTIVITIES THAT CATALYZE DISCOVERY AND LEARNING ABOUT CRAFT FOR ALL AGES, BACKGROUNDS, AND INTEREST LEVELS. IN FY25, THE CENTER WELCOMED 11,542 GALLERY VISITORS, EXHIBITED THE WORK OF 54 ARTISTS, AND HOSTED 1,448 VIRTUAL PROGRAM
