Verify Clinical and Academic Responsibilities Prior to Rotation

Before starting your subspecialty rotation, ensure the following items are reviewed and confirmed:

- **Clinic Schedule:** Review the IMC schedule for your assigned half-day clinics.
- **Call & Cross-Cover:** Confirm all call shifts and cross-cover responsibilities on the master schedule.
- **Additional Academic Duties:** Verify any other required responsibilities, including day pager coverage, presentations (e.g. PCC presentation), CBT sessions, OSCE, SIM, or other scheduled activities.

- Completion and confirmation of all clinical and academic responsibilities listed above

- Typical daily schedule is from 7am to 5pm
 - Residents are to begin each day at 7am reviewing EKGs and will be assigned patients by the cardiology fellow to see in follow up or consultation
 - Consults and follow ups should be seen and notes completed prior to rounds with the attending
 - Cardiology Conference is scheduled every Friday from 0700-0800 in JUVE Conference Rooms - Mandatory Attendance
 - All rotators will have scheduled time in cardiac rehab, stress testing, echocardiogram lab

CCU

Notes:

- Residents are expected to report to the CCU work area (central room on T1/HLU) for sign-out (@1800) on the day prior to the start of their rotation unless their assigned schedule does not allow (eg. vacation, post-call, off-site, etc.)
 - if unable to attend it is the responsibility of the resident to obtain sign-out from the prior team
- CCU (HLU TS) patients will be covered by the resident team up to the team limit (5 per intern)
 - If team limit is reached PRIOR to rounds, the list should be cut in discussion with the teaching attending
 - Patient's beyond the team limit that are cut from the teaching list will be seen by the clinical fellow who is responsible for writing notes, placing orders, and rounding on these patients with the teaching attending
- Residents may be asked to see a non-teaching patient in an emergent scenario and they should communicate with the fellow or attending regarding that patient to staff
- Senior residents and interns will rotate daytime call responsibility (holding the pager) and respond to:
 - CODE STEMI – in the hospital and ED
 - CODE BLUE – in the ICU tower
- For NSTEMI, a GRACE score should be calculated and documented in the notes. P2Y12 inhibitors should not be given before cath unless they are already on one, are not a candidate for CT surgery, or the attending has specifically requested it be given
- Cardiology Conference attendance is expected every Friday 0700-0800 in Juve Conference Rooms
- 0600-1830 is the typical daily schedule • 1800-0630 is the typical night coverage schedule
 - Residents are not to leave from their clinical responsibilities until the end of their scheduled shift and cannot be dismissed by other residents

- This is not an academic exercise. You (the residents and medical students) are responsible for the treatment and care of the patients in the CCU. Take ownership of the management of your patients' care. Question everything. Read up on your patients' problems. Challenge what you do not think is right or may be done differently.
- Residents should dig deeply into patients' histories including contacting the PCP and cardiologists' offices for old records as well as the surgeons for old operative notes. Contact outside PCPs, outside cardiologists and family for more information.
- Complete physical examinations are required on patients being admitted. "RRR" is not acceptable as a cardiac exam documentation in a coronary care unit.
- A patient's chart is a method of documentation and communication to other health care providers about a patient's problems and plan of treatment. A breakdown in communication is one of the leading causes of errors in medical care

Emergency Medicine

Initial Point of Contact:

- Residents will get a schedule emailed prior to beginning of the month and with instructions on where to present on your first day.
- On the first day of the rotation, residents should report to the doc box in the middle of the ED at least 10 minutes prior to the start of their shift. They should read the rotator handbook prior to their first shift.

- Residents can expect to receive their rotation schedule 1 month prior to their rotation, along with a rotation overview packet/handbook.
- Residents can expect to work 9 shifts over 2 weeks or 18 shifts over one month. All shifts will be scheduled at the Akron City ED. Residents should strive to see one patient per hour.
- Any off-shift requests must be communicated more than **2 months** prior to the start of the rotation to **BOTH** Jessica Repko (or current EM Scheduling Chief Resident) AND the Internal Medicine Chief Resident(s).
- We recommend not taking "vacation" during ED Rotation as the shift requirement does not decrease with Vacation.

Endocrinology

Notes:

- Residents are to check-in with Mandy Mergy daily at her office on 7E at 0800 and/or 1300 (if at IMC in the morning) and are expected to be ready to begin at the time of check-in – rounding faculty will rotate weekly
- Consults take place at Akron City Hospital and are assigned to the residents as they come in – workload should be shared evenly by the available team (residents scheduled in IMC in the morning are not “available” until after noon conference)
- Consults and follow-ups should be seen and notes completed prior to rounds using the .hemonc and .proghemonc templates – rounding time is at the discretion of the rounding faculty
- Residents will be scheduled for half-days in the clinic with Dr. Jakob – additional outpatient time may be available on request
- Morning MKSAP question review will take place with Dr. Jakob, usually 3 morning per week which he will communicate with the rotators

Infectious Disease

- Consults take place at Akron City Hospital and are assigned to the residents as the consults come in – workload should be shared evenly by the available team (residents scheduled in IMC in the morning are not “available” until after noon conference)
- Residents will complete 1 week seeing patients in either the ID office or the CARE center and should determine this schedule on the first day of their rotation
- Morning lectures take place each Monday, Tuesday, and Thursday at 0730 in the ID office or Conference Room B in the Department of Medicine – Attendance is MANDATORY. **Residents with morning clinic are expected to attend lecture until their first patient arrives.**
- Combined clinical rounds may take place on Wednesdays with Microbiology, Immunology, and Pathology at 1300 in Laboratory Wing 3rd Floor Conference Room (**Lim Conference Room**)– discuss with your attending to see if taking place
- Microbiology plate rounds, led by microbiologist, are every Tuesday and Thursday at 1100 in the microbiology lab.
- Resident team is expected to present at least one case at ID conference on the third Friday of the month.

 - All rotators are scheduled for 1 week of outpatient neurology and should consult their schedule for assigned dates and locations
- Note templates will be shared by Neuro APPs at the start of the rotation to ensure most recent versions of templates.
- When on Stroke Service, residents are to immediately respond to Stroke Teams while on the stroke service (except when seeing patients in the IMC) from 0700-1700 unless otherwise directed by their attending
- We do request bringing their pagers to receive stroke team pages, may not always be able to hear them overhead.

 - Rotators will attend Fellow led lectures, beginning at 7:30AM on MWF
- All rotators are scheduled for 2 half days of outpatient addiction medicine per week and should consult their schedule for assigned dates and office locations
- Rotators will participate in 1 half day of IOP per rotation (2 or 4 weeks)
- The decision regarding wearing a white coat is left to the discretion of the rotator. Except in the case of IOP, do NOT wear a white coat to the IOP half day
- Residents will be presented with a recommended reading list. This list is curated by ADM fellows and attendings to include high yield material in the field of Addiction Medicine. It is expected that residents will complete this reading list over the course of their rotation. Half days on Friday are set aside for residents to work towards this goal.

- Residents are scheduled to mirror the schedule of an assigned hospitalist during their rotation (either full month or partial month).
- New consults/admission and follow ups will be assigned to the residents by the attending physician, and notes should be completed prior to rounding with the attending – prior to placing or changing orders, residents should communicate with their attending for their preferences in that regard
- Residents are to begin each day at 0700 and review their patients from the prior day as well as newly assigned patients (up to a maximum total of 10 patients)
- The goal of this rotation is to allow residents to supplement their skills in the management of hospitalized patients and gain a clear understanding of the role of a hospitalist in the medical system
- The resident will round at least once per day with their assigned attending on their scheduled hospitalist days
- This is not an academic exercise; the resident is responsible for the treatment and care of these patients with the goal of getting the resident more ready for unsupervised practice in the inpatient setting.
- Typical hospitalist shifts will be scheduled (typically 0700-1700) Tuesday-Monday on alternating weeks to create a “7-on 7-off” schedule. Throughout the rotation, whether “7-on” weeks or “7-off” weeks, the resident will continue to attend their assigned IMC shifts and are expected to maintain their required noon conference attendance.

ICU Elective (aka ICU Gold)*
