#### Old business:

2719 Erie Avenue, a.k.a. Hyde Park Square South Block Redevelopment
The developer, HPSRD, LLC, has rescinded its application for a Planned Development.
Consequently, City Council voted unanimously on September 4, 2025, to repeal its former ordinance creating a Planned Development. The developer indicated in news articles its intent to reapply at a later date with a "scaled down" plan.

#### New business:

1255 Meriweather Avenue

The applicant is the owner of a single-family residence (SF-6 zone) seeking to add a covered deck in the rear yard. The addition requires a variance of 4'4" on the side yard setback and 30' on the rear yard setback. The ZC voted to oppose the application, for now, in the absence of a survey, full site plan, and input from neighbors. Should more information become available, the ZC may reevaluate.

#### 1. **Guests**:

**Cincinnati Police Department, District 2 Officer Monique Martin:** Officer Martin distributed the crime statistics and noted:

- They had great attendance at the National Night Out event, despite the rain.
- Despite continued pleas from the police not to do so, people continue to leave key fobs in their car. Please don't do this. Additionally, please don't leave personal items in your car in plain view.
- Please call District 2 if you see a suspicious vehicle or person in your neighborhood. They may not respond right away, but they will have a record of this. A recent report of a suspicious person led to the arrest of someone suspected of stealing packages from porches.
- District 2 is working to set up directed patrols at Ault Park in the overnight hours in response to some recent incidents there.
- District 2 is continuing to investigate the reported lewd act that occurred along Wasson Way.

### **Withrow University High School**

Belinda Carson reported that:

- Withrow is getting ready for the new school year, which begins August 20<sup>th</sup>.
- Withrow will be teaching students in grade 9-12 only this year. 7<sup>th</sup>-8<sup>th</sup> graders will be taught at Evanston Academy.
- Withrow currently has an interim principal and is searching for a permanent principal.
- 45% of Withrow students are English as a second language(ESL) learners. The school is currently trying to put together a Welcome Center for ESL families where they can provide resources and meet with those families. The school may need help getting some furniture for this effort.
- The school is still looking for shelving and/or storage solutions so that Belinda can organize and manage the supplies and clothing that she distributes to students in need.

- Public safety is very important to him, especially when it comes to setting the appropriate bond. He tries to coordinate with services in the jails for mental health and addiction.
