DoaC25/10/03: To approve the minutes of the DoaC meeting held on 8th September

Resolved: Cllr Hillier proposed and Cllr Prosser seconded that the minutes of the DoaC meeting held on 8th September 2025 be approved. All voted in favour.

DoaC25/10/04: To consider a request from Olney Fire Station crew

Deputy Town Clerk informed committee members present of a request from Olney Fire Station crew to attend the event with a fire appliance for demonstration and recruitment purposes.

Resolved: Cllr Bethune proposed, and Cllr Prosser seconded that the request to attend be accepted. All voted in favour.

DoaC25/10/05: To consider VIP luncheon nominations

Deputy Town clerk reported that more than thirty local people had been nominated. **Resolved:** Cllr Whitworth proposed, and Cllr Bethune seconded that a maximum of nine nominees be invited to a VIP luncheon by the Mayor. All voted in favour.
