<b>CONDITIONS OF EQUIPMENT USE</b>		
<p>1. "Equipment" means all Equipment including any accessories supplied on hire by FTL to the Customer (and where the context so permits shall include any supply of Services). The Equipment shall be described on the invoices, quotation, authority to hire, or any other work authorisation form provided by GTL to the Customer.</p> <p>2. "Minimum Hire Period" means the Minimum Hire Period as described on the invoices, quotation, authority to hire, or any other forms as provided by GTL to the Customer.</p> <p>3. The Equipment shall at all times remain the property of GTL and is returnable on demand by GTL. In the event that the Equipment is not returned to GTL in the condition in which it was delivered GTL retains the right to charge price of repair or replacement of the Equipment.</p> <p>4. GTL will be responsible for maintaining the Equipment including the Certificate of Compliance every ten (10) years.</p> <p>5. The Customer shall:</p> <p>(a) keep the Equipment in their own possession and control and shall not assign the benefit of the Equipment nor be entitled to lien over the Equipment.</p> <p>(b) not alter or make any additions to the Equipment including but without limitation altering, make any additions to, defacing or erasing any identifying mark, plate or number on or in the Equipment or in any other manner interfere with the Equipment.</p> <p>(c) keep the Equipment, complete with all parts and accessories, clean and in good order as delivered, and shall comply with any maintenance schedule as advised by GTL to the Customer.</p> <p>(d) keep the Equipment at the address that has been agreed upon by GTL and shall not move the Equipment from this location unless prior written authorisation has been provided by GTL.</p> <p>6. The Customer accepts full responsibility for the safekeeping of the Equipment and the Customer agrees to insure, or self-insure, GTL's interest in the Equipment and agrees to indemnify GTL against physical loss or damage including, but not limited to, the perils of accident fire, theft and burglary and all other usual risks and will affect adequate Public Liability Insurance covering any loss, damage or injury to property or persons arising out of the use of the Equipment. Further the Customer will not use the Equipment nor permit to be used in such a manner as would permit an insurer to decline any claim.</p> <p>7. Notwithstanding the above clause, immediately on request by GTL the Customer will pay:</p> <p>(a) any lost hire charges GTL would have otherwise been entitled to for the Equipment, under this, or any other hire agreement;</p> <p>(b) any insurance excess payable in relation to a claim made by either the Customer or GTL in relation to any damage caused by, or to, the hire Equipment whilst the same is hired by the Customer and irrespective of whether charged by the Customer's insurers or GTL's.</p> <p>8. Return of the Equipment ("Return") will be completed when:</p> <p>(a) the Equipment is returned by the Customer to GTL's place of business; or</p> <p>(b) when GTL takes back possession of the Equipment once collection by GTL is affected.</p>
