Beans: Late fee = \$110.00 per field. After Aug 1 late fee = \$110.00 plus 2x acreage fee per field

Grain: Seedling inspections \$6.20 / acre. Applications due within 15 days of planting.

Grain: Late fee = \$ 110.00 per field prior to July 1st. After July 1st the fee = \$110.00 per field plus 100% of the acreage fees

All other crops: Late fees = 10% of the acreage fee with a minimum late fee of \$34.00

Grass: Applications not accepted more than 120 days after planting

Grass: second reinspection fee = \$90.00 plus \$1.10 per acre

No seed potato applications postmarked after June 25 will be accepted

Reinstatement fees are to be charged for each delinquent year.

It is the growers responsibility that all fees are paid.
