

## Test and Certification

This chair has been tested for strength, durability, and safety through independent third-party verification in accordance with EN 16139 Level 2, making it suitable for extreme use. The wood is sourced from sustainably managed forests and certified by PEFC through independent third-party verification.

The Clear Oil features a low VOC content and is fully compliant with EU regulations. This product contains no biocides, ensuring a natural and environmentally responsible finish. Worker safety is a high priority, with all processes conducted under controlled conditions in accordance with unions and national regulations.

## Materials, Process and Finishing

Handcrafted with care from solid European oak, the frame is carefully detailed with woven surfaces using paper cord. It combines Brdr. Krüger's skilled joinery with modern technology to achieve precision and lasting quality. Hand-assembled using time-honored techniques for strength and durability. Surfaces are finely sanded by hand for a smooth, tactile finish, and a clear oil is applied to protect the wood while preserving its natural character.

## Fumed Oak Process

For a deeper tone, the oak undergoes a traditional fuming process, where it is exposed to a small amount of ammonia vapors in a sealed environment for 20 hours. This reaction with the wood's natural tannins enhances the grain structure and deepens the color. As a natural, non-surface-based treatment, no dyes are used, preserving the wood's authentic character. Variations in hue may occur depending on the tannin content of each piece.

## Craftsmanship Statement

We support and foster the Danish cultural heritage of craftsmanship by preserving and advancing the traditional techniques nurtured in our family workshop since 1886. This commitment reflects both the preservation of the craft and its evolution through the integration of new techniques, innovation, and design development.

Originally created for the historic Danish restaurant Noma, the ARV Chair was designed to be both elegant and enduring, standing up to the needs of refined hospitality environments.
