Terms and Conditions

1. The pearls in the auction are sold according to Lots identified by number, weight, and quantity.
 - a. Buyers should inspect each lot to verify the quantity, weight and other information of pearls in a lot.
 - b. The Seller provides no warranty regarding the accuracy of the number, weight, or quantity of pearls and related items in any lot. This information is intended solely as a general guideline.
2. Pearls will be sold by competitive biddings.
 - a. The Seller reserves the right to refuse acceptance of any bid.
 - b. The Seller may withdraw any lots from sale at any time prior to the conclusion of a sale.
3. Before the Seller accepts any bids, a buyer may revise a previous bid by submitting a correction bid. Correction bids must be submitted in the correct manner set by the Seller.
 - a. The highest correction bid will be recognized as a buyer's final bid and will cancel a buyer's previous bid.
 - b. Any corrections or cancelled bids from buyers following the release of results may result in the seller exercising the right to cancel the lot. In such cases, a penalty of no less than **15%** of the bidding price will be imposed.
 - c. In the event that payment is not received from the buyer prior to the expiration of the established payment terms, the seller reserves the right to revoke the buyer's eligibility for future bidding, as well as any outstanding bids.
4. If the Seller receives more than one bid in the same amount for a particular lot, the Seller is subject to their right to refuse any bid, and may determine the acceptable bid by a draw.
5. All bids must be expressed in United States Dollar (\$), in a minimum unit of 1 USD.
6. The Seller holds the ownership of all pearls until the full price has been paid according to the accepted payment methods and conditions of sale.
 - a. Upon payment, the full ownership and risk are passed to the buyer.
7. All sales must be paid before delivery of the pearls. The buyer will pay the cost of the transfer of funds, freight, and insurance.
8. Payments are due no later than the specified due date, which is, 14 days from the conclusion of the auction.
 - a. If payment is not made for a lot by the due date, the sale of the lot may be cancelled by the Seller, whom may claim damages from the defaulting buyer.
9. Payment may be accepted in Hong Kong Dollar (HKD), United States Dollar (USD).
ALL USD CASH PAYMENTS IS SUBJECT TO 0.30% TRANSACTION FEE.
 - a. The FX rate will be decided by the Seller.
