- Article 6 — Restrictions on substances of concern, including PFAS
- Article 10 – Packaging minimisation requirements
- Annex VII — Technical documentation requirements

Specifically we confirm that:

4.1 Design and Composition

The packaging is designed and composed in accordance with PPWR requirements applicable from 12 August 2026. All materials used are recyclable.

4.2 Substances of Concern — PFAS and Restricted Substances

The producer confirms, on the basis of written statements of compliance obtained from its material and component suppliers, that:

- Per- and polyfluoroalkyl substances (PFAS) are not intentionally added to any packaging material or component;
- To the best of the producer's knowledge, based on supplier declarations, no restricted substances under Article 6 of the PPWR are present in the packaging above applicable threshold levels;
- The combined concentration of lead, cadmium, mercury, and hexavalent chromium within the relevant supplied board grades is below the applicable PPWR threshold.

4.3 Packaging Minimisation

The packaging has been designed to minimise weight and volume in accordance with Article 9 of the PPWR.
