Carol seconded. Motion passed unanimously.</p> <p>Transfer of accounts and passwords. Meeting scheduled on Thursday, October 25th with Akilah to provide the board access to various online accounts.</p> <p>Hiring process. Gail’s full-time contract is being reviewed by Kirstin. EC will handle the contract, and will circulate the contract for comments to the whole board.</p> <p>Communications to Players. Letter to players, etc, should we notify the players about the resignation and how.</p> <p>Charli moved that Corey announce Gail’s hiring at the rehearsal on Tuesday, October 24th. Barbara seconds.
