



It is pleasing to report that Athletics South (AS) has had another successful year of competition in both our winter cross country (XC) and summer track and field (T&F) seasons.

Winter XC was enjoyed by participating athletes and our Winter Competition Director and her committee have worked hard to ensure a successful winter program. Venue for John Keenan Memorial XC was moved from the Domain to Seven Mile Beach. Further venue changes may be undertaken in the coming season to lessen course expenses, and any changes will be after consultation with athletes.

Summer T&F competition was also enjoyed by participating athletes, although it was noted that some paid up registered athletes did not compete in interclub. Our T&F Director has always attempted to make variations in the interclub program to better suit athlete's desires. End of season survey this year received good response, and comments made will help in preparation for next years interclub program.

Public Relations & Media Director has continued to provide articles / photos for press publication, and many athletes have featured. Articles are prepared and submitted for publication however, media space determines published article length and/or photos.

Board members keep a constant 'eye out' for grant funds available, and seek grants for amenities and equipment purchases. Canteen profits are also directed towards equipment purchases. This year purchases for equipment and amenities exceeded \$50,000.

Clubs provide a vital role to athletes in providing support, comradery within the club, and friendly rivalry within the club and the AS family. Clubs undertake the weekly set up and packing away equipment. It is pleasing to see athletes volunteering to support club officials with these tasks and also assisting officiating at various competition sites throughout the meet.

Club representatives from Eastern Suburbs, Northern Suburbs, OVA Saints, Sandy Bay Harriers and Tasmanian Masters continue to be active contributors to the AS Board of Management meetings. By being active at Board of Management meetings they contribute to the many discussions and decisions, and provide instant information feedback to their club members.

Coaches support their athletes, providing encouragement and support to assist them reach their goals. They coach athletes in all weather conditions, attend coaching sessions and provide support, guidance and every assistance regardless of the athletes' ability. Without our coaches and their valuable contribution, our athletes would not enjoy the sport, meet their goals, or mature as determined young men and women. Coaches can be proud of the talent they have nurtured.

Athletes love to catch up with friends, both within their club and other clubs, and to enjoy friendly rivalry at meets. Many help out their club administration needs each week and

develop a sense of belonging. AS is fortunate to have a good mix of 'social' athletes as well as emerging elite athletes, many of which choose to compete interstate, Oceania and National Championships (Junior, Open and Masters). Pinnacle highlight for 2024 was Jacob Despard being selected in the Australian Olympic Team. The Tasmanian team attending Nationals at seasons end returned home with many personal bests and Tasmanian records.

Officials worked tirelessly to ensure all events (winter & summer) ran smoothly, successfully and were enjoyable for all athletes. Congratulations to all officials for your contribution, professional approach and dedication.



TRACK & FIELD REPORT

The recent Athletics South Track & Field season saw some interesting changes, trends and viewpoints, which were inconsistent with the other post-covid years. Indications this year were that our members no longer want flexible programming, and variation of times, and would rather go with consistent competition timing and the same rotational programming. This was emphasized in the post season survey, and will be reflected in the programming for the upcoming season. Our competition numbers were also considerably down on past years, despite registered numbers being consistent, with a number of reasons being given for that in the survey as well.

Due to the Athletics Tasmania rotation, Tasmanian Championships were held in Launceston this season, with AS hosting the All Schools, and this, along with uncertainty as to combined Championship events did lead to some programming difficulties, and I thank all for working around these.

At this stage, it looks like dates will be set much earlier this season, meaning a more definite calendar will be issued earlier, with changes due to the Tasmanian 5000m Championships no longer overlapping with an interclub, as well as both AT and LAT Championships being held in Hobart, with the Tasmanian Championships hopefully being the conclusion of the season, thus avoiding the normal drop off post Championships.

Whilst it is only a small part of my role, the Athlete of the Year awards continue to be a highlight, and we look forward to expanding this next year by implementing at least 1, if not more, para categories to run alongside our age categories, which, unfortunately, didn't occur this season. As our para numbers continue to grow, this is a move which will see all athletes have more appropriate recognition and see all treated equally when these award recipients are nominated and considered.

As this is likely to be my last year in this role, I thank all those who have supported me over the years, and hope to have the same support this year, as I start my transition out, with a gradual handover to the likely next person to fill the role.

PUBLIC RELATIONS REPORT

The Public Relations role continues to grow with social media being used as the primary form of communication with members. This includes use of the Messenger function as a means of enquiry rather than the traditional use of phone or email. The Athletics South Facebook and Instagram pages were used on a regular basis throughout both the summer and winter seasons to provide information and promotion of events. The AS Facebook Page now has 1,446 followers, with Instagram having 721. Photos for interclub events were shared each week and received a high level of positive engagement. A big thanks to Holly Smee for her assistance in providing quality images for use on the AS social media pages and in the Mercury.

Articles posted on Facebook now automatically uploaded to Facebook for those who don't use social media. Outside of this, the website is primarily used as a repository for information, including event calendars, programs, regulations, contact details and results. Thanks are extended to Jarrod Gibson (summer) and Chris Sullivan (winter) for the role they play in making results available on the website after each interclub event.

During the Summer Season, a report was provided each week to the Mercury in relation to the AS Interclub Track and Field competition. Some preview stories were provided, along with post-meet articles providing details of the standout performers. There is a short window of time in which to prepare an article for publication and difficult to be across all the good performances that occur each week, but I have tried my best to give coverage to all events.

Three grant applications to Active Tasmania were submitted during the year, all of which were successful. The first was an infrastructure grant of \$26,000 to construct a shelter at the 200m start at the DAC. This was installed with the support of the Hobart City Council, who provided project management and administration. The second was a grant of \$12,962 to purchase a new high jump mat and cover. Unfortunately, a delay in the delivery of the cover has prevented the new equipment from being used to date but it will be ready to go for the new season. Finally, a grant for \$7,034 has been received from the Active Clubs program to purchase new starting blocks and throws equipment – some of which will be to support participation by athletes with a disability.

At the end of the Track and Field Season a survey of members was undertaken to provide feedback into the product being offered by Athletics South. The survey received 127 responses, and the results will be considered by the incoming AS Board as part of their planning for next season. It is clear that members want to see some changes and improvements to the way in which the sport is delivered, and I hope that we can all work cooperatively to deliver the best outcomes possible.

In closing, I extend my thanks to all the wonderful volunteers involved in our sport for their tireless efforts for the athletics community
