(1) Baseline footprint to inform Our Pathway to Net Zero strategy launched in 2023. Mears Group has historically (pre-2021) used a financial control method of calculating our carbon footprint. During the development of Our Pathway to Net Zero strategy, it was determined that an operational approach would be more appropriate given the nature of Mears Group's business operations and ability of Mears Group to directly control or influence carbon reduction activities. This enables Mears Group to have more opportunities over time at a local level to impact and reduce our carbon footprint to meet our Net Zero Carbon aspirations. 2021 footprint has been restated (see point 6 below).

(2) Independently externally verified pursuant to ISO 14064, part 3.

(3) Emissions comparison v 2021 baseline. Note that emissions reductions in Scope 1 and 2 were in part due to reallocation of emissions to Scope 3 and addition of new Scope 3 categories/reporting as part of our best practice carbon management ongoing continuous improvement of reporting (see point 6 below).

(4) Mears reports on UK market based scope 2 emissions from 2021.

(5) A Scope 3 materiality assessment was undertaken in 2024 and an ongoing mapping exercise is underway to continually enhance our understanding of Scope 3 emissions and further Scope 3 emissions will be reported in future as we improve reporting alongside identification of actions to influence their reduction with Our Pathway to Net Zero strategy (see point 6 below).

(6) The GHG emissions have been restated for 2023, 2022 and 2021 pursuant to Mears policy of restating carbon and energy figures in consideration of changes in methodologies, improvements in the accuracy or discovery of errors in previous years' data to provide a more accurate and comprehensive accounting of the Mears Group carbon footprint. This revision includes the reallocation of emissions from Scope 1 and Scope 2 to Scope 3, along with the inclusion of additional emissions sources. These new sources encompass waste recycling/disposal, Well to Tank (WTT) emissions, Transport and Distribution (T&D) emissions, as well as emissions from water usage and purchased goods. This forms part of our best practice carbon management ongoing continuous improvement of reporting.
