

Addendum

Requirements for Certification Version 14

Publication date: 2 July 2025





1. SCOPE

This document forms an addendum to the GWO Requirements for Certification version 14, published on the 1st of April 2025. This addendum provides the requirements for extension of scope certification of the new GWO Solar Training Standards released the 2nd of July 2025.

This addendum applies to:

- a. Training providers already certified to deliver GWO Basic Safety Training (BST) and Basic Technical Training (BTT) Electrical and Installation modules seeking extension of scope certification to deliver Solar Safety Training (SST) and Solar Technical Training modules (STT)
- b. Training providers already certified to deliver Solar Safety Training (SST) and Solar Technical Training (STT) modules seeking extension of scope certification to GWO Basic Safety Training (BST) and Basic Technical Training (BTT) Electrical and Installation modules

The additional clauses below, are continuations to the existing provisions, sections and clauses outlined in the Requirements for Certification version 14. Therefore, the clause numbers correspond to GWO Requirements for Certification version 14 section 6.4.

6.4 Additional clauses pertaining to 6.4 Extension of Scope:

- 6.4.10 If a training provider that is already certified to deliver the First Aid module in the Basic Safety Training (BST) standard wishes to deliver the First Aid Module and First Aid Awareness Module in the Safety Solar Standard (SST), additional certification is required. The extension of scope audit shall focus on validating the management system and the qualification of the instructors. A guidance for the total duration of this audit would be one hour and the audit can be remote.
- 6.4.11 If a training provider that is already certified to deliver the Fire Awareness, Manual Handling and Working at Height modules in the Basic Safety Training (BST) standard wishes to deliver the Safe Solar Work module in the Safety Solar Standard (SST), additional certification is required. As a minimum the audit must include the one-hour audit of the management system and witnessing of training for three hours. A guidance for the total duration of this audit would be four hours and it must be a physical audit.
- 6.4.12 If a training provider that is already certified to deliver the Electrical module in the Basic Technical Training (BTT) standard wishes to deliver the Electrical module in the Solar Technical Training (STT) standard, additional certification is required. As a minimum the audit must include the one-hour audit of the management system and witnessing of training for three hours. A guidance for the total duration of this audit would be four hours and it must be a physical audit.
- 6.4.13 If a training provider that is already certified to deliver the Installation module in the Basic Technical Training (BTT) standard wishes to deliver the Installation module in the Solar Technical Training (STT) standard, additional certification is required. As a minimum the audit must include the one-hour audit of the management system and witnessing of training for three hours. A guidance for the total duration of this audit would be four hours and it must be a physical audit.



- 6.4.14 If a training provider that is already certified to deliver the First Aid Module in the Safety Solar Standard (SST), wishes to deliver the First Aid module in the Basic Safety Training (BST) standard, additional certification is required. As a minimum the audit must focus on validating the management system and the qualification of the instructors. A guidance for the duration of this audit would be one hour and the audit can be remote.
- 6.4.15 If a training provider that is already certified to deliver the Safe Solar Work module in the in the Safety Solar Standard (SST) wishes to deliver the Fire Awareness, Manual Handling and Working at Height modules in the Basic Safety Training (BST) standard, additional certification is required. As a minimum the audit must include the one-hour audit of the management system and witnessing of training for three hours (one hour per module). A guidance for the total duration of this audit would be four hours and it must be a physical audit.
- 6.4.16 If a training provider that is already certified to deliver the Electrical module in the Solar Technical Training (STT) standard wishes to deliver the Electrical module in the Basic Technical Training (BTT) standard, additional certification is required. The necessary audit must include the witnessing of training for three hours. A guidance for the total duration of this audit would be four hours and it must be a physical audit.
- 6.4.17 If a training provider that is already certified to deliver the Installation module in the Solar Technical Training (STT) standard wishes to deliver the Installation module in the Basic Technical Training (BTT) standard, additional certification is required. The necessary audit must include the witnessing of training for three hours. A guidance for the total duration of this audit would be four hours and it must be a physical audit.
