Survey Methodology

Interview Dates

July 27th – July 29th, 2025

Target Population

National registered voters

Sampling Method

The survey was administered using a non-probability online panel with voter verification protocols. All respondents were matched to a commercial voter file to confirm registration status. Quota controls were applied during recruitment to ensure representative coverage of age, region, race, gender, and educational attainment within the registered voter population.

Weighting

The sample was weighted using a multi-level iterative proportional fitting (raking) approach. First-stage weighting adjusted for demographics (age, gender, educational attainment, race), geography (region, area type), and recalled 2024 presidential vote. Second-stage weighting adjusted for party identification and voter political engagement metrics such as election participation history.

Weighting targets were derived from comprehensive analysis of national voter files, certified 2024 election results, and U.S. Census demographic data to ensure accurate representation of the national registered voter population and the 2024 electorate.





Republican Job Approval & Top Issues

Trump Job Approval Stabilizes at 46 Percent, 5 Points Underwater amid Hardened Opposition


The gap is driven by 59% of independents and 56% of women disapproving. Disapprovers are also more intense in their opinions – 88% of Harris voters who disapprove of Trump, do so strongly compared to 63% of Trump approvers doing so strongly.

Trump's ratings tick up a few points in August: border security climbs from 48% to 50% approval, foreign affairs returns to parity at 50%, and jobs & economy stabilizes


Q. Do you approve or disapprove of the way President Trump is handling the following issue...




Republicans in Congress Hold at 43% Approval, 8 Points Underwater, with Disapproval Stuck Above 50% Since April

Independents (31 % / 60 %) drive the gap between Trump's approval. House GOP approval has hovered in the low-40s for months, signaling a stubborn ceiling but stabilized opinion.

Q. Do you approve or disapprove of the job Republicans in Congress are doing?







Senate Republicans Hold at 43% Approval, 8 Points Underwater — Converging with House Ratings but Still Three Points Behind Trump

Softer Republican and right-leaning Independent backing temper approval relative to Trump, while Democratic opposition stays firm, leaving Senate Republicans 8 points underwater and 3 points behind Trump.

Q. Do you approve or disapprove of the job Senate Republicans are doing?






Generic Ballot at 44% – 47% Is Tighter Than Trump's Approval Gap, with Both Sides Highly Committed and 21% of Independents undecided

Republicans stay in striking distance: 67% of voters who say they are voting for the GOP are "definite," matching Democrats' 69%, and 21% of independents remain undecided leaving ample room for GOP gains as the midterms come into focus.


Q. If the election was held today would you vote for the Republican or Democratic candidate for U.S. Congress?



Top 2024 Campaign Issue Inflation and the Cost of Living Still Dominates Voters' Agenda as Border Security Drops to a Distant Third

25% of voters (**35% of independents**) name inflation and the cost of living as the top problem. Corruption in government moved to second (12 %), edging out immigration/border (11 %), after a week dominated by Russiagate and Epstein investigation news.



Two-Thirds of Voters Now Know A Lot or Some About OBBB, With Only 12% Being Unaware, A Massive Shift From Two Months Ago

66 % have heard "a lot" (32 %) or "some" (34 %) about the bill; awareness peaks at 78 % among college-educated voters and 77 % among seniors. Awareness slips to 60 % with independents and just 47 % among 2024 non-voters.


Q. How much have you seen, read, or heard about the tax and domestic policy bill, also known as the "One Big Beautiful Bill Act"?



OBBB is Narrowly Underwater as Voters Learn More — 70% of Opposers Do So Strongly, Outpacing Supporter Intensity


48% of voters are undecided or have soft opinions - the opportunity to define OBBB is still there, but critics are winning the message battle. Only 54% of Republicans strongly support the bill, compared to 78% of Dem opposers who strongly oppose it.

GO ON OFFENSE: Messages attacking Democrats for what they voted against boosts Republicans – Defending OBBB benefits alone falls flat

Messages about Democrats protecting illegals on Medicaid and voting for the largest tax increase in history boost GOP generic ballot position. **Don't just defend OBBB, use OBBB to draw a clear contrast between GOP and Democratic values and priorities**



Attacks against Democrats work because voters believe there is real abuse of Medicaid – but they worry OBBB will go beyond strengthening the program

Voters agree that there is real fraud and abuse in Medicaid that needs to be addressed (46% - 42%), but 48% of voters believe that OBBB will go well beyond abuse and end up reducing healthcare for millions who legitimately qualify

Most convincing arguments in defense of OBBB Medicaid changes are removing over 1 million Illegals, Then framing changes as "Common-Sense" Anti-Fraud Reforms

Top message promises to remove 1M illegal immigrants from Medicaid (+29 net), followed by "stop \$500 B fraud with common sense reforms" (+25). While morale argument around the dignity-of-work lags (+16). Keep the focus on kicking illegal immigrants off the rolls and strengthening the system for who it was intended for with common sense reforms.

America First Priority Net Convincing Not convincing This doesn't cut healthcare for Americans who need it — it puts Americans first by removing over 1 million illegal immigrants from Medicaid. Reinforce attacks with bread-and-butter relief for families and the workingclass. Voters are persuaded by tax cuts and relief for families

Tax relief and family specific policies are the best testing provisions of OBBB. Permanently lowering taxes for 80% of taxpayers, making child-care credits permanent, eliminating taxes on tips/OT and boosting the Child Tax Credit win over voters.

Note: Voters were shown pairs of bill provisions at random and asked which provision made them more likely to support OBBB. The provisions were then scored on how well they performed against other provisions.

Voters respond to tangible, kitchen-table relief and family-oriented benefits paired with a credible justification for crackdowns on waste and fraud

Protecting Medicaid for those who truly qualify (+5.7) and promising a 15 % tax cut for working families (+3.2) are the clear winners, while deficit jargon (-0.8) and border-security spending pitches (-2.5) fall flat.

Note: Voters were shown a supporter message and a critic message at random and asked which was a more convincing argument for or against the bill. Messages that won more match ups against Democratic criticisms received a higher ModelNet score.


Voters Break Even on Fiscal Impact of OBBB, Yet 39% Expect It Will Leave Their Family Worse Off and only 27% Say It would Make Them Better Off

Just 42% say OBBB "pays for itself," while 44% believe it will add debt. Pocketbook expectations tilt farther negative: 27 % think they will be better off versus 39 % worse, with an 18% gap among independents (19% / 39%).
