### Your role

You will work with PRIMS on a daily basis to build and maintain high-quality PIFs, perform and document Cosmetic Product Safety Reports (CPSRs), and provide clear, well-reasoned guidance to clients and colleagues.

This role is ideal for a scientifically strong, analytically minded toxicologist who enjoys structure, data and digital tools, and who wants to grow into a senior Safety Assessor / regulatory expert.

## Key responsibilities

In close collaboration with senior Safety Assessors and Regulatory Specialists, you will:

### Perform safety assessments

- Contribute to/prepare cosmetic product safety assessments (CPSR Part A & B) under EU Cosmetics Regulation 1223/2009 and related frameworks (e.g. UK cosmetics regulation, US MoCRA, other key markets depending on experience).
- Assess ingredient safety based on toxicological profiles, exposure scenarios and margins of safety.
- Support assessments for special product categories (e.g. children, around the eyes, leave-on vs rinse-off, high-risk ingredients, sensitizers).

## Build and maintain compliance dossiers

- Support PIF building and maintenance in PRIMS, ensuring dossiers are complete, consistent and audit-ready.
- Review and structure input data from clients (formulas, raw material documentation, test reports, packaging and labels).
- Help keep documentation aligned with latest regulatory and toxicology updates through PRIMS.

### Regulatory and labelling support

- Review product labels, claims and marketing texts against EU/UK requirements and, where applicable, retailer lists or other programmes.
- Contribute to notifications/registrations (e.g. EU CPNP, UK SCPN, US listings) and related documentation.
- Work in a digital compliance environment
  - Use PRIMS to analyse current and future compliance, generate reports and support portfolio-level risk assessments for clients.
  - Provide feedback to help improve workflows, data structures and algorithms in PRIMS together with the software team.

- Affinity with non-animal / NAM-based approaches and modern safety assessment concepts is highly appreciated.

- Strong analytical and conceptual thinking; comfortable working with data, thresholds and scenarios.
- Accurate, structured and comfortable working with digital tools and databases (experience with any regulatory/safety software is a plus).
