

**ORDINANCE NO. 25 – 12 – 2P**

**AN ORDINANCE DIRECTING AGAINST PROPORTIONAL REDUCTION  
IN THE AGGREGATE EXTENSION OF THE TAX LEVY OF THE  
SCHAUMBURG PARK DISTRICT FOR ITS FISCAL YEAR  
BEGINNING APRIL 1, 2025 AND ENDING MARCH 31, 2026**

**WHEREAS**, the Schaumburg Park District (the “District”) has heretofore duly adopted Ordinance No. 25 – 12 – 1P, an Ordinance Levying Taxes of the Schaumburg Park District For Its Fiscal Year Beginning April 1, 2025 and Ending March 31, 2026 (the “2025 Tax Levy Ordinance”); and

**WHEREAS**, under the circumstances and conditions set forth in the Property Tax Extension Limitation Law (“PTELL”), in the event a reduction to the District’s aggregate extension is required under PTELL, the County Clerk is directed to proportionally reduce the aggregate extension of each fund of the District unless otherwise requested by the District; and

**WHEREAS**, the Board of Park Commissioners of the District has determined that it is in the best interests of the District, and of the residents and taxpayers of the District, that the County Clerk be directed against proportional reduction in the above described 2025 tax levy (the “2025 Tax Levy”) of each fund of the District which is subject to reduction under PTELL, in the event the District’s 2025 Tax Levy is limited by reason of PTELL;

**NOW, THEREFORE, BE IT ORDAINED** by the Board of Park Commissioners of the Schaumburg Park District, Cook County, Illinois, as follows:

**Section One:** The County Clerk is hereby requested and directed against proportional reduction in the 2025 Tax Levy of each fund of the District which is subject

to reduction under PTELL, but instead shall make such reductions as are set forth below in Section Two herein, to the extent reductions are required under PTELL.

**Section Two:** In lieu of proportional reduction in the 2025 Tax Levy of each fund of the District which is subject to reduction under PTELL, the County Clerk is directed as follows:

The County Clerk is directed not to reduce the 2025 Tax Levy of the following funds more than the percentages set forth opposite the name of the Fund:

<u>Fund</u>	<u>Percent of Reduction</u>
(1) Corporate	0%
(2) Recreation	100%
(3) Public Liability Insurance	0%
(4) Audit	0%
(5) IMRF	0%
(6) Handicapped Fund	$\begin{array}{r} 0\% \\ \hline 100\% \end{array}$

Except that, in the event that any further reduction must be made under PTELL, the County Clerk is directed to allocate such further reduction to the fund listed below:

Museum Fund

**Section Three:** The Secretary is hereby directed to file a certified copy of this Ordinance with the County Clerk on or before the time required by law.

**Section Four:** If any section, paragraph or provision of this Ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this Ordinance.

**Section Five:** All prior Ordinances and Resolutions in conflict or inconsistent herewith are hereby expressly repealed only to the extent of such conflict or inconsistency.

**Section Six:** This Ordinance shall be in full force and effect upon its passage and approval.




