
Council Updates-



WHEREAS, the Annual Business Session will occur on Thursday, April 30th, 2026; and




This Resolution shall become effective immediately upon its adoption.

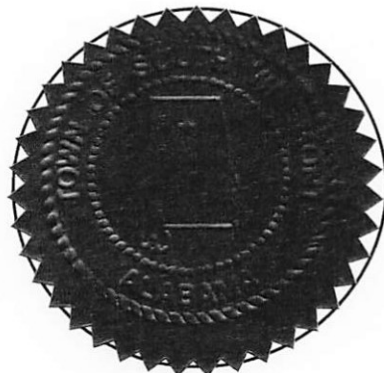
