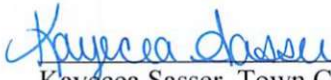
Clerk made mayor and council aware that for the Community Clean Up day we gave out fifty-two permits, we only filled one dumpster and total cost was \$584.06.

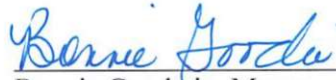
Citizen Question:
