The AI system under assessment is a Microsoft Copilot Pro-based chatbot, designed to support external website visitors through natural language interactions and appointment booking, while also acting as a productivity assistant for internal users within Microsoft 365 applications (Outlook, Word, Excel, Teams). The individuals, groups and societies include external users, internal staff, vulnerable persons, data subjects, the organisation and oversight roles such as the Information Security Manager and the AIMS Manager, together with the Leadership Team. Their needs and expectations include accurate, reliable, transparent and accessible responses that respect privacy, minimise bias and align with organisational governance requirements. The intended use is to provide routine query handling, content summarisation, document drafting, and productivity support in a controlled environment under ISO/IEC 42001 policies. The reasonably foreseeable misuse includes prompt injection or jailbreaking, impersonation of staff, over-reliance on outputs without human oversight and inappropriate handling of sensitive data. These factors establish the scope of the impact assessment, which covers foreseeable impacts on individuals, groups and the organisation. This assessment is complemented by data protection and human rights considerations where relevant.


