

2020 CA Aussie Freeeee Flight Competition Terms & Conditions

About the Competition

1. The promoter of the Camp America's 2020 CA Aussie of the Year Competition ("the Competition"), NSW permit number is LTPS/20/42394, Camp America ("the Promoter"), 10-14 Oxford Square, Darlinghurst, NSW 2010 (ABN 58 067 638 499).
2. The Promoter respects your right to privacy and will only process personal data you provide to us in accordance with the Privacy Act 1988 and other applicable privacy laws. For more information see the Camp America Privacy Policy at www.campamerica.com.au.
3. By entering the Competition you agree to the following terms and conditions, to be bound by the decisions of the Promoter, and to receive email notifications from the Promoter in relation to the Competition and the Camp America program.

Entering the competition

4. This Competition is open only to permanent Australian residents who are aged 18 or over who have a fully complete CA reaching an Ready To Place (RTP) stage this includes, first and second payment, two references, an Australian Federal Police Check and . Employees (or their relatives) of the American Institute for Foreign Study (or any other company and/or agency connected with this promotion) are not permitted to enter.
5. The competition is open from **00:00 am ADST Saturday 1st of February – 12:00 pm AEST Tuesday 31st of March 2020**. To enter the competition participants must have their complete application and made both payments by March 31st.
6. Only one entry per person. No entries on behalf of third parties will be accepted.

Entry Draw

7. Entries will be drawn by the Promoter on Tuesday 31st, March 2020 at 1:00 pm (ADST), at the offices of the Promoter, 10-14 Oxford Square, Darlinghurst NSW 2010.
8. The Promoter's decision is final and no correspondence will be entered into. Winners are drawn by chance.

The Prize

Judging backup entries
