Facts of the case are that on 11-11-2024 at 1600 hours received a Telugu written complaint from Sri. B. Janaiah, DSP, DCRB Vikarabad, in which he stated that as per the orders of District Collector "Public Opinion" proprgamme is scheduled on 11-11-2024 at 11 AM at the outskirts of Lagacherla village which is situated between Hakimpet and Duydal routes, in view of proposed to procure the land to Telangana Industrial infrastructure corporation. In this regard as per the orders of SP Vikarabad he reached the above said place for Bandobusth on 11.11.2024 on 10:00 hours. While Sri. Lingya Naik, Addl. Collector of Vikarabad District, Sri. Uma Shanker, In charge collector of Tandur and MRos and TGIIC official were also reached the place of "Public Opinion" and at about 12 PM Sri. Prateek Jain, Collector, Vikarabad District along with Sri. Venkat Reddy, Special Officer of KADA also came to the place of public opinion and waiting for people in the

meantime one person who wear green colour towel came to there and requested the Hon'ble Collector that to conduct the meeting in the village itself otherwise none of them come to there i.e. to the outskirts of Lagacherla village. By believing the request of him, MRO Kodangal vehicle in front and next Collector Parthiak Jain vehicle, after KADA officer Venkat reddy vehicle, Additional collector Lingya Naik vehicle, Parigi Dsp Karuna Sagar reddy vehicle and after his vehicle one after another were proceeded to Lagcherla village, while they were reached in-front of Chellapuram Venkataiah house, in the meantime, the persons of unlawful assembly by names 1. Devadas, 2. Polepally Vishal, 3. Erlapally Raju, 4. Lokya Naik, 5. Gopal Naik, 6. Vittal Naik, 7. Ramu Naik, 8. Bhogamoni Suresh, 9. Vishnuvardhan Reddy, 10. Sonibai, 11. Laxmamma, 12. Sevya Naik, 13. Neerati Raghavender, 14. Neerati Anji, 15. Neerati Suresh and others most of the people ladies formed themselves into an unlawful assembly with stones and sticks and obstructed the Additional collector Lingya Naik and beat him with stones and sticks, while his vehicle proceeding towards into the village the said persons damaged the Additional collector Govt. Vehicle. Immediately he rescued the additional collector Lignya Naik from their clutches and send him away from there in Police vehicle. Further he observed at Anjaneya Swamy temple, the car bearing No. TS15FE9339 belongs to MRO Kodangal, TGIIC official car bearing No. TS08UH0057 (White Colour) also damaged. If he not rescued Additional collector from the clutches of above persons, otherwise they will definitely kill him. Hence the FIR
