12.07.2024 Heard Ms. M. Hazarika, learned Senior Counsel assisted by Ms. S. Newar, learned counsel for the petitioners. Also heard Mr. J. Handique, learned Standing Counsel for the Revenue Department representing the respondent nos. 1 and 2; and Mr. N. Goswami, learned Government Advocate appearing for the respondent no. 3.

- 2. The learned Senior Counsel for the petitioners has submitted that the Standing Counsel for the KAAC representing the respondent nos. 4 to 7 was informed for listing of the matter today. None appears on call for the said respondents.
- 3. The petitioners claimed to have been in occupation of Government land for the last 60 years and in this writ petition filed under Article 226 of the Constitution of India, the petitioners have assailed order No. KAAC/Rev- 2045/2024/776 dated 20.02.2024 issued by the Principal Secretary (I/C), KAAC, by which a direction has been issued to the Assistant Revenue Officer, Donika Revenue Circle to take necessary steps for eviction of the unauthorized occupants.
- 4. The learned Senior Counsel for the petitioners has submitted that the petitioners have document to show their continuous presence on their respective land for the last 60 years which is by way of entry made in the chitha and also supported by payment of touzi bahira revenue. By referring to the statement made in paragraph 10 of the writ petition, the learned Senior Counsel has submitted that in the area in which the eviction is envisaged, there are 2008 nos. of household with the estimated

population of 11,664 nos. with 5 numbers of polling station centre and the description of the Government Institution and Public Facilities on the said land are also given therein.

- 5. In view of the above, issue notice returnable on 05.08.2024.
- 6. Requisite extra copies of the writ petition be served upon the learned State and Departmental Counsel within two working days.
- 7. As an interim measure and till the returnable date, it provided that the impugned order No. KAAC/Rev-2045/2024/776 dated 20.02.2024 shall remain Page No.# 9/9 suspended only in respect of the 22 numbers of petitioners herein.
- 8. The petitioners shall serve certified copy of this order to the Principal Secretary, KAAC (respondent no. 5) to bring this order to the notice of the said authority.
- 9. List on 05.08.2024.
