to issue a Writ Order or direction more particularly one in the nature of Writ of Mandamus or any other writ or direction in the nature of the writ a To direct Respondent No 1 to roll back its decision of allotting the said land to Respondent no 4 and declare the action of the Respondent No 1 as illegal perverse adverse violation of its powers and in violation of the environmental laws along with other laws b To direct the cancellation of the proposed ELF radar Project in the Damagundum reserve forest which is a very fragile eco system and would lead to irreparable damage if established c To cancel the GO MS No 21 dated 03/09/2014 d To direct the respondents to Conduct a thorough environmental impact assessment of this Project by an Expert Agency/Committee and produce the report to this Honorable court e To conduct thorough assessment of Traditional wisdom socioeconomic and cultural aspects of this fragile ecosystem of the localites on the conservation of this forest area f To direct the Respondent No 1 to produce all the documents regarding the allotment and transfer of land to Respondent no 4 g To direct the respondents to follow the rules and procedures as prescribed in law h To direct the respondents to conduct a public hearing with the locals regarding the project i To direct the respondent no 2 to make a Peoples biodiversity register according to the Biological Diversity Act 2002 j To direct the respondents to give the locals/Gram Panchayats the Patents rights for the Medicinal and other plants available in the forest k To direct the respondents to not interfere with the rights and peaceful movement/freedom of the worshipping in the Temple till this case is pending and post the same
