JUSTICE DINESH MEHTA

Order

1. The petitioners have approached this Court with an apprehension that the State Government would allot the land situated in village Ola, Malusar, Bahala Basti, Tehsil Pokaran/Fatehgarh, District Jaisalmer to the respondent no. 6 pursuant to the communication dated 03.02.2025.
2. Learned counsel for the petitioners submitted that the petitioners are having a residential house(s) constructed on some



part of the land in question and are also having electricity connection among other amenities. Learned counsel submitted that if the subject land is allotted to the respondent no.6, it will prejudice the petitioner's right.

3. Admittedly, the petitioners are neither having any title in their favour nor are they having any semblance of right declared by any competent authority to hold such land.

4. Be that as it may. The communication dated 03.02.2025 (Annexure-6) is only to the extent of seeking objection/representation. The petitioners may file their objection before the District Collector, Jaisalmer, who shall consider the same in accordance with law.

5. The writ petitions stand disposed of.

6. Stay applications also stand disposed of, accordingly.
