



*All legal issues and venue and exclusive jurisdiction shall be in Palm Beach County, Florida, USA.*

- All sponsor tabletops are allocated on a first come, first served basis. The floor plan and tabletop positions are subject to change.
- GMTIS reserves the right to release your tabletop if the contract has not been signed and returned along with full payment being made within 14 days of receiving this contract.
- Medical Tourism Association retains the right to reject any sponsor that does not follow the appropriate procedures or provide requested information.
- On receipt of the signed contract, the sponsor will receive an invoice for payment and be expected to pay by credit card or bank wire within 14 days. If payment by bank transfer has been deemed acceptable the sponsor will be invoiced, and we expect payment to be made within 14 days of the invoice date. If payment is not made, you will be contacted, and your tabletop will be released.
- Unless otherwise stated, your sponsor tabletop is only provisionally booked until payment is received.
