Richard Bissell-3557-362- He stated the community is all one community even though we have 2 entities. This community needs money and it must come from us.

Both Guy Munday and Fred Hicks responded to this comment reminding the community that the BVSA intends on keeping their fiduciary responsibility to the membership.

Debra Crawford - 3431-185- asked how the CSD is billing the water? So many units and so many dollars.

Fred answered there is a conversion problem and each meter is read in units. There may be a check and balance problem. We are using the metrics and doing the math and it is not coming out correct. We have a running 5 year historical data document.

Rick Zanutto- 3557-006- Rick stated the lease and rec credit and water billing should have been taken care of in the Liaison meetings. He is very disappointed. He wants to comment on the gift giving of public rentals. He reviewed the grand jury reports and their recommendations coming from them. The BVCSD GM stated the CSD has to answer the findings and recommendations. He said there would have been findings that came forward from the Grand Jury. Yes, these things should be paid for by the members but it needs to come out of the right pocket. Review of the amenities is supposed to be done annually. The BVCSD should have been doing that and telling the BVSA what they expected to be completed. He stated he has great knowledge of the D-fac (park and rec funds). Fred Hicks and Rick Zanutto discussed the lake fill, depth of lake and other items pertaining to water rights and the lease. He does want the CSD and BVSA to get together and talk. He doesn't understand how we got to this point. He is asking us to think collaboration.

Fred asked about the grand jury reports he mentioned. Rick said the Grand Jury understood the lease at that time and they understood how the community operates.

Debbie Mayer 5412-002- She encouraged our Board to not let the animosity that is coming from the CSD deter us.

Richard Bissell- stated he disagrees that it is a misappropriation of public funds. The money comes from the public. Taxes and HOA fees are all paid by the public.

Suzie Vliestra-3430-019- she wants to thank everyone here that wants to learn. She wants to remind us how unique and unusual our wonderful community is. She said the relationship is like a marriage and we are going through a rough patch, and we need to get some counseling and figure this out. Communication, Collaboration and Celebration.
