BVSA received letter from BVCSD stating they are in violation of lease agreement particularly with the trails and the cover for the campground kitchen as well as approximately ten other items. The BVCSD is asking that the association pay the CSD \$900,000 to lease the amenities as well as other requirements; i,e, wanting to know what all club events are occurring, the amount the clubs make and many other items. The BVSA sent out the information to homeowners and a survey with regard to the lease and quality of management of amenities. Bob Tebbe spoke of the property adjacent to the Loop Ranch stating this land could bring in thousands of dollars if sold or leased to the conservancy. This is a CSD issue and the member asked if he would give consideration to proposing this to CSD. Don also acknowledged Suzi for her contribution to the beautification/landscaping of the equestrian center.</p>
