The Rio Grande Ave., construction is complete and final closeout documents are in the process.

Veater Street: A total of 5 bids were received, the responsive bid was submitted by Las Cruces Construction, LLC for a total amount of \$607,375.25. Wilson & Co. performed a certified bid evaluation and has identified that the bid package submitted by Las Cruces Construction, LLC has met the required criterion of responsiveness.

The Doris Ave. Street Project is in the final stages of completion.

An application was submitted for East Riverside in the amount of \$1,157,131.96 through the TPF project program, which will include design, construction, construction management including full reconstruction of the roadway with the addition of ADA – compliant sidewalks.

The Wastewater Project is in the construction phase. Smith Co has completed the clean out phase and will start on the next phase in July 2025.

West Riverside Ln: Wilson & Co. is at 90% design completion.
