# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to bethnawrocki.com and Beth Nawrocki and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Beth Nawrocki include bethnawrocki.com. The Beth Nawrocki website is a health and wellness site. ## **Collection of your Personal Information**

In order to better provide you with products and services offered on our Site, Beth Nawrocki may collect personally identifiable information, such as your:

- First and Last Name

# **Sharing Information with Third Parties**
