Tenancy application

General information

- 1. After viewing the property-fill out the attached application form COMPLETELY, leaving no blanks.
 - For start date, enter the earliest possible date that you will take the property after the available date, provide 100 points of ID and proof of income with the completed application form.
 - INCOMPLETE FORMS WILL NOT BE PROCESSED.
- 2. Rent is payable calendar monthly in full on the 10th day of each month. Please note our office is cash free.
- 3. Calendar monthly rent is calculated by the following approved formula:
 - Weekly rent divided by 7 multiplied by 365 divided by 12.
 - Eg: \$380 divided by $7 = 54.28 \times 365 = 19812.20 divided by 12 = \$1651.19 per month
- 4. A Bond equal to 4 weeks rent is required at the time of the lease sign. This can be paid by bank cheque or money order.
- 5. ALL people living in the property that are over the age of 18 years are required to complete an application form and be on the Tenancy Agreement (except dependant children). Joint applications need to be lodged together. ALL applicants must sign the application form.
- 6. The Agent is not obliged to contact all referees. The agent will only contact referees and complete TICA checks on preferred applications.
- Please advise your referees that you have given their details to us. A delay in the ability to contact referees may mean that we are unable
 to present your application to the Landlord for approval.
- 8. The Final decision will be made by the lessor of the property & no reason for their decision will be given.
