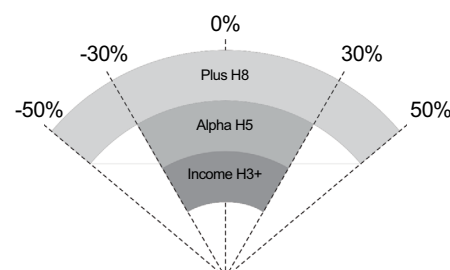

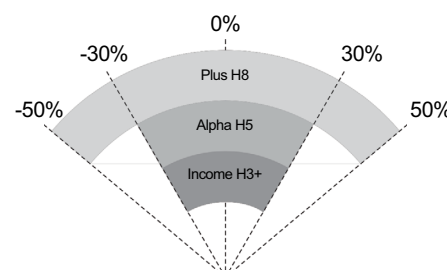


Asset Allocation
