
Strategy Overview

The Master Investment Strategy pursues a strategy of maximum diversification, investing across a wide range of asset classes including equities, bonds, property and alternatives, in order to maximise returns per unit of risk.

It is not necessary for the strategy to target aggressive returns, but to achieve an 'optimal' balance between risk and return.

The underlying assets of the Master Investment Strategy are carefully selected to create a highly diversified portfolio largely consisting of individual securities, although investment trusts, exchange traded funds, actively managed funds and other investments may also be used.

Master Strategy Allocations




PRISM Strategy Overview

PRISM offers a full spectrum of defined risk-return profiles, with performance driven from a single 'optimal' investment strategy. This Master Investment Strategy is a highly diversified investment portfolio that aims to optimise returns per unit of risk.

Each PRISM profile has a defined mean return and a defined volatility which, together with the performance of the Master Investment Strategy, are used to calculate returns in each period. These defined risk-return profiles are published in advance, providing investors and their advisors clarity as to the expected performance characteristics of their investment.





Investment Commentary

The PRISM Master Portfolio rose 2.5% in July, with equities doing the heavy lifting while property lagged. Within equities, US tech leadership reasserted itself, and Emerging Markets and Europe also contributed meaningfully as rate expectations steadied into month-end after both the Fed and ECB left policy unchanged.

Emerging Markets performed well, driven by TSMC's Q2 results and outlook, which pointed to sustained Al foundry demand. Vietnam Enterprises, a Vietnam-focused investment trust, also contributed strongly. This was largely due to the provisional trade agreement with the US, announced on 3 July, which marked a positive turning point for sentiment.

Moving to Europe, Remy Cointreau reported good organic sales growth its first growth quarter since 2023 and raised profit guidance, with the US making a strong rebound. Vestas Wind enjoyed solid order momentum and supply chain tailwinds, and JPMorgan upgraded the stock. Both Europe names gained over 20% during the month.

Al continued to drive returns for Microsoft, Nvidia, Alphabet, and Oracle, all of which delivered double-digit gains. Microsoft both beat expectations and raised guidance, supported by strong demand for Azure and Al workloads.

We remain positive on the Healthcare sector, though performance was mixed during the period. Thermo Fisher beat estimates and raised guidance, while AstraZeneca delivered good results with positive late-stage pipeline updates.

Novo Nordisk disappointed after issuing a profit warning and lowering guidance, but we remain confident in the long-term success of its diabetes and obesity drugs. Over the last 15 years, Novo has achieved a consistently high ROIC of over 30%, underlining its ability to deliver sustainable returns. Given this, we took the opportunity to increase our position. UnitedHealth also disappointed, with Q2 results reflecting a balance between utilisation pressures, cyber-incident costs, and stable membership trends.

Housebuilders underperformed during the period. Barratt Redrow, and Persimmon all fell after the CMA investigated whether major housebuilders had distorted competition. Rather than going to court, the companies agreed to contribute towards affordable housing programs.

We have slightly reduced equity exposure following the recent strong momentum and added modestly to fixed income. In our view, markets have rallied too far, too fast, and we have therefore cut our global equity allocation back to neutral.



Performance




