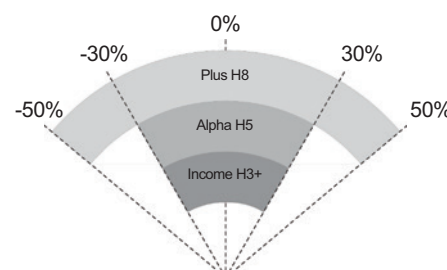

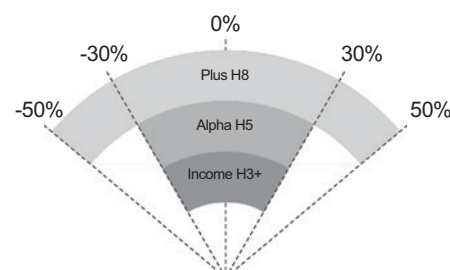


Asset Allocation
