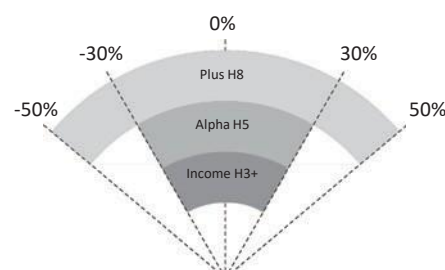

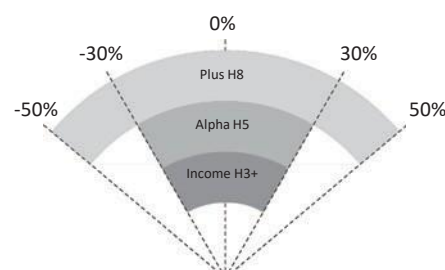


Asset Allocation
