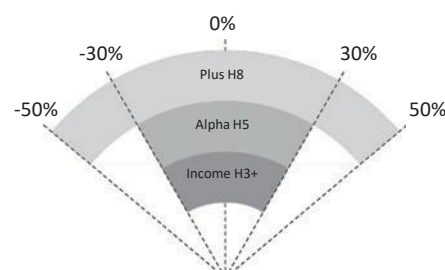

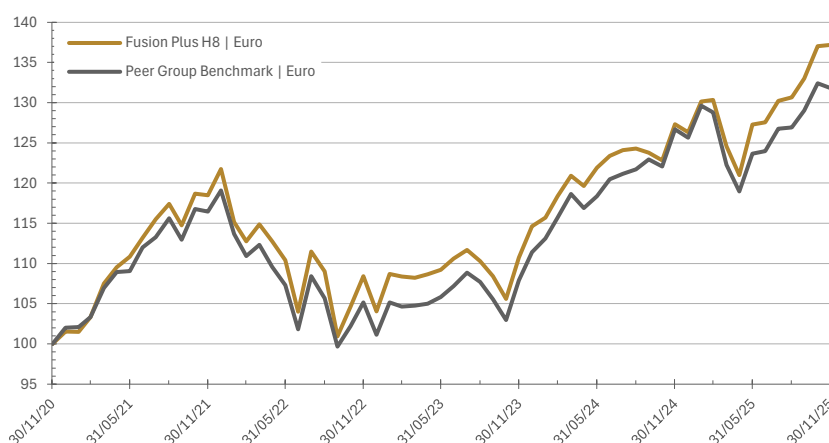

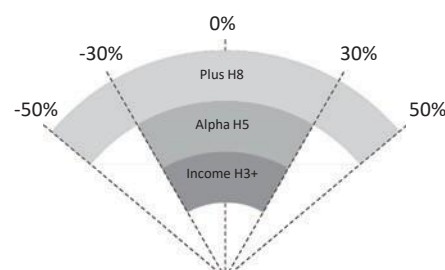


Asset Allocation
