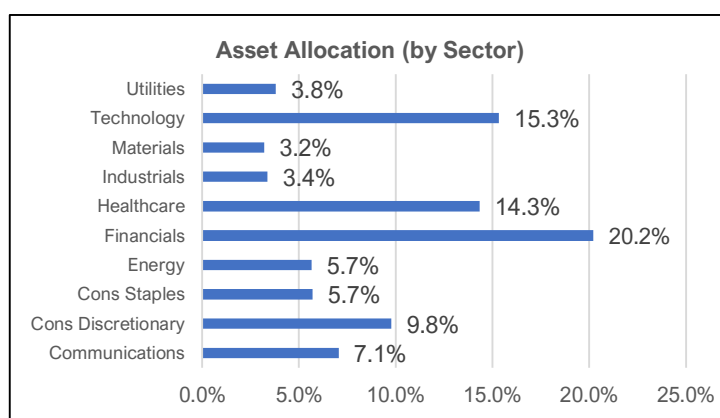
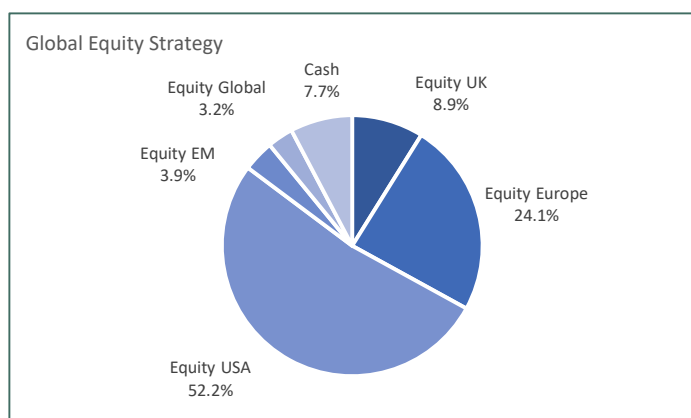


**Strategy Description**

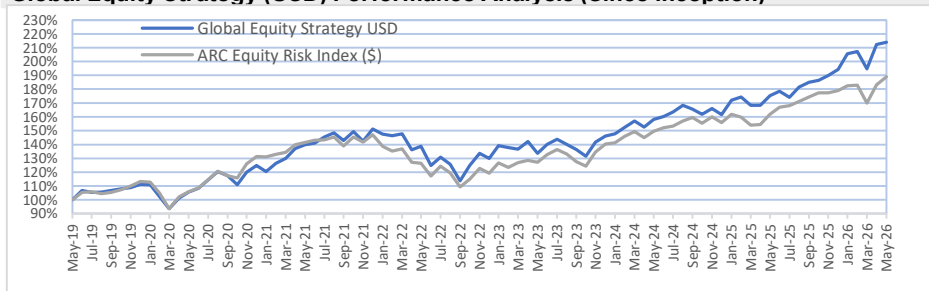
