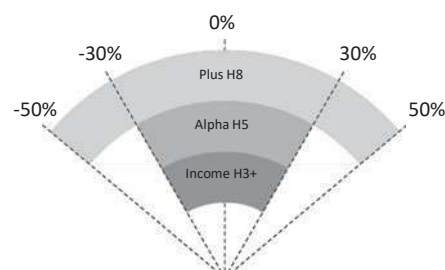

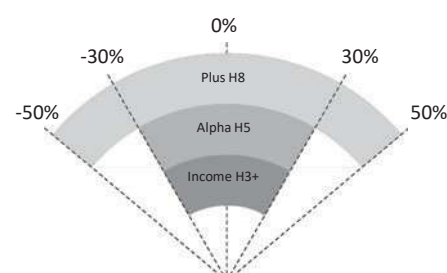


Asset Allocation
