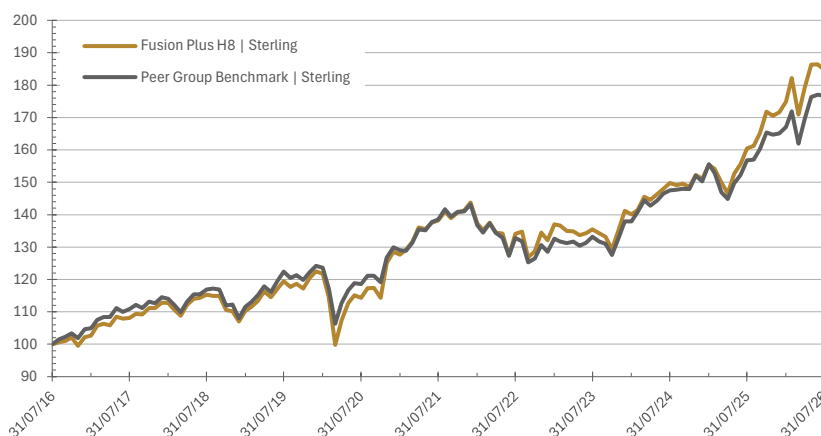

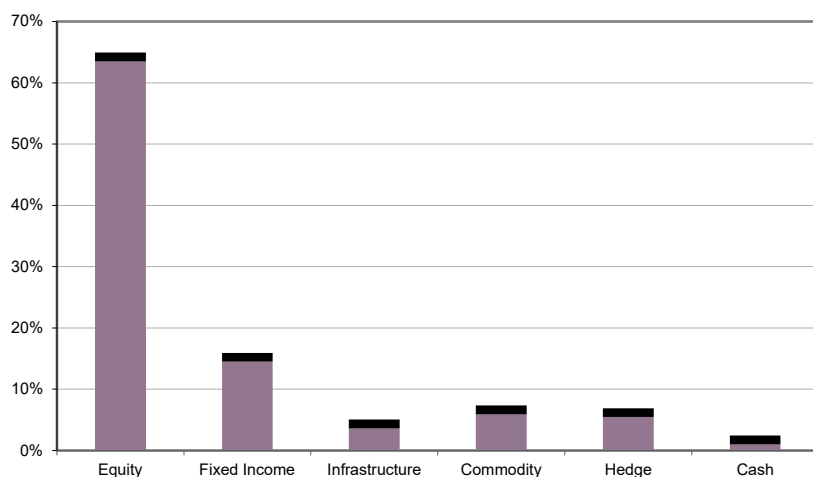

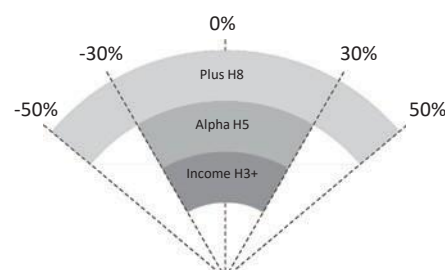


Asset Allocation

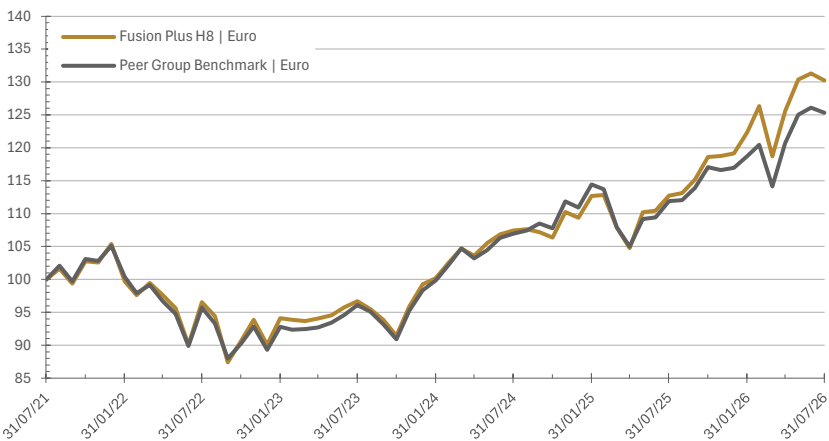

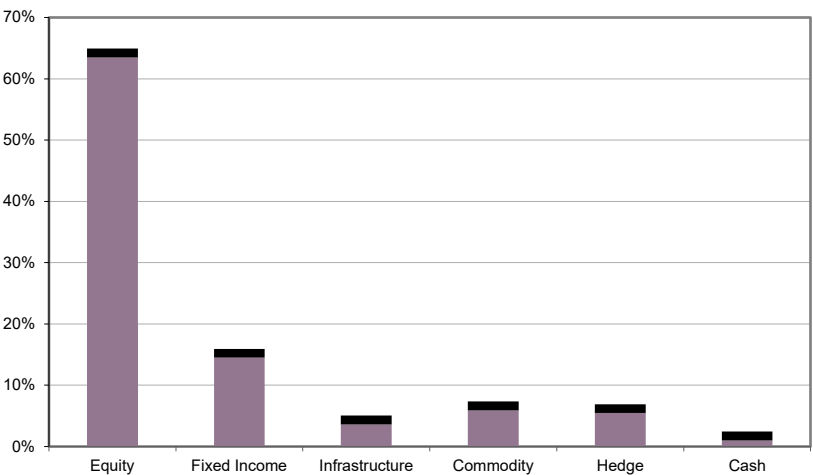

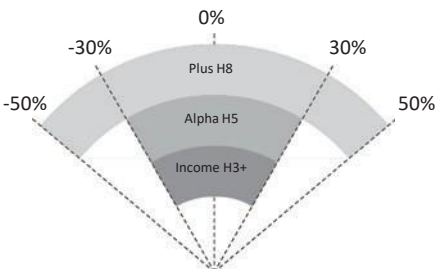


Asset Allocation
